## EC/Czech republic Europe agreement: additional protocol

1994/0297(AVC) - 04/12/1995

The Council decided to conclude the Additional Protocols on the participation of Bulgaria , Hungary , Poland , Romania and the Czech Republic in Community programmes. The Protocols were signed during the summer of 1995 and the European Parliament gave its assent on 15 November 1995.

## **EC/Czech republic Europe agreement: additional protocol**

1994/0297(AVC) - 04/12/1995 - Final act

-OBJECTIVE : conclusion of an additional protocol to the EU-Czech Republic Europe Agreement. -COMMUNITY MEASURE : Council and Commission Decision 95/562/EC, EURATOM concluding the Additional Protocol to the EU-Czech Republic Europe Agreement. -SUBSTANCE : the protocol shall be concluded for an unlimited period and covered exclusively Community areas of competence. The Czech Republic would participate in a range of Community programmes and initiatives in the following fields : - research and technological development (Fourth Research and Technological Development Framework Programme), - information services, - the environment (LIFE), - education, training and youth (SOCRATES, LEONARDO, Youth for Europe III), - social policy and health, - consumer protection, - small and medium-sized enterprises, - tourism, - culture, - the audiovisual sector (MEDIA programme), - civil protection, - trade facilitation, - energy (THERMIE, ALTENER, SAVE), - transport, and - the fight against drugs and drug addiction. The parties might agree to add other fields of cooperation to those listed above. An Association Council would decide the terms and conditions for the participation of the Czech Republic in the various programmes listed. The Czech Republic would have to meet the costs resulting from its participation and, if necessary, the Community could decide, on a case-by-case basis, to pay a supplement to the Czech Republic's contribution. -ENTRY INTO FORCE : two months after the date upon which the Parties notified each other of the completion of the necessary procedures.

## **EC/Czech republic Europe agreement: additional protocol**

1994/0297(AVC) - 15/11/1995 - Text adopted by Parliament, 1st reading/single reading

In adopting the report by Mr POSSELT (EPP, D), Parliament gave its assent to the proposal to conclude an Additional Protocol to the EU-Czech Republic Europe Agreement.

## **EC/Czech republic Europe agreement: additional protocol**

1994/0297(AVC) - 08/02/1995 - Legislative proposal

This proposal for a Council and Commission decision aimed to conclude an additional protocol to the Europe agreement between the Community and Euratom of the one part, and the Czech Republic of the other part. This protocol, concluded for an unlimited period, covered exclusively Community areas of responsibility. In fact, it aimed to involve the Czech Republic in a series of Community programmes and initiatives in the following fields: - research and technological development (4th Framework Programme for Research and Technological Development), - information service, - environment (LIFE), - education, training and youth, (Socrates, Leonardo, Youth for Europe III), - social policy and health, - consumer protection, - small and medium-sized enterprises, - tourism, - culture, - audiovisual sector (MEDIA Programme), - civil protection, - facilitation of exchanges, - energy (Thermie, Altener, SAVE), - transport, - fight against drugs and drug addiction. In addition to these fields, the parties could agree together to add other areas of cooperation to this list. The Czech Republic's participation in these programmes would help promote its integration in the European Union and help it to become more familiar with the methods of managing Community programmes in all areas. An Association Council would determine the procedures and conditions for the Czech Republic's participation in the various programmes listed. The Czech Republic should take responsibility for the costs of its participation and, if necessary, the Community could decide, on a case-by-case basis, to supplement its contribution. With regard to the procedures required for the entry into force of this protocol, ratification by each Member State would not be required since this protocol only covered Community areas of responsibility.
