Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 26/02/1997 - Economic and Social Committee: opinion, report

The Committee approves the Commission proposal.

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 17/09/1997 - Text adopted by Parliament, 1st reading/single reading

Parliament approved the proposal (procedure without debate).

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 27/03/1998 - Commission communication on Council's position

The Commission fully endorses the common position.

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 23/03/1998 - Council position

This is concerned with consolidation of texts and the common position follows the Commission proposal, adding a number of technical corrections without political content.

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 22/06/1998 - Final act

OBJECTIVE: consolidation of Directive 89/392/EEC, which has been amended several times. COMMUNITY MEASURE: Directive 98/37/EC of the European Parliament and of the Council. SUBSTANCE: The directive aims to consolidate Council Directive 89/392/EEC on the approximation of the laws of the Member States relating to machinery. The new directive replaces the various directives which have been consolidated. ENTRY INTO FORCE: 12/08/1998.

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 13/12/1996 - Legislative proposal

The aim of this proposal is the consolidation of Council Directive 89/392/EEC on the approximation of the laws of the Member States relating to machinery. The new directive will supersede the various directives incorporated in it; their content is fully preserved, and it only brings them together, making only such formal amendments as are required by the codification exercise itself.

Approximation of the laws of the Member States on machinery (codified version)

1996/0305(COD) - 30/04/1998 - Text adopted by Parliament, 2nd reading

The European Parliament approved the common position.
