PURPOSE: to appoint Mr Jean-Francois BERNICOT to the Court of Auditors. COMMUNITY MEASURE : Council Decision 2001/784/EC, ECSC, Euratom. CONTENT : Mr Jean-Francois BERNICOT is appointed a member of the Court of Auditors for the period from 1 January 2002 to 31 December 2007.
