2003/0008(CNS) - 05/06/2003 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted the report drafted by Dominique F. C. SOUCHET (IND, France) and amended the Commission's proposal. (Please see the document dated 20/05/03. Parliament stated that, since the implementation of Regulation I766/92EC, intervention prices have been reduced five times, making a total of 45%, whereas, over the same period, the consumer price index in the EU has risen by 25.5%. In real terms, therefore, the reduction in the intervention price amounts to 56%. Parliament added that cereals prices in Europe are now virtually on a par with international prices. An intervention price for cereals is fixed at EUR 101,31/tonne. The intervention price valid for maize and sorghum in May will remain valid in July, August and September of the same year. Parliament felt that intervention in respect of rye should be restricted to a certain period of time and should occur only in those places for which no alternatives to growing rye have been found which are justifiable from the agricultural and economic points of view. This would lead to lower intervention stocks of rye and would preserve jobs and incomes in disadvantaged areas. Furthermore, a regulating mechanism should be set up to encourage the use of rye in animal feed and as a raw material for special technical applications and energy production. The Commission must propose before 31 December 2004, a plan to encourage the use of rye on the internal mark

2003/0008(CNS) - 21/01/2003 - Legislative proposal

PURPOSE: to repeal and replace Regulation 1766/92/EC on the common organisation of the market in cereals. CONTENT: a final 5% reduction (of the 20% proposed in Agenda 2000) is proposed to bring the cereals intervention price down to EUR 95.35/t from 2004/05 to ensure that intervention is a real safety net. To avoid a further accumulation of intervention stocks, rye will be excluded from the intervention system. With the diminishing role of intervention, a seasonal correction for the intervention price will no longer be justified. It is therefore proposed to abolish the monthly increment system. Production refunds for starches and certain derived products will no longer be applied. As a consequence of the cut in cereal intervention price, area payments for cereals and other relevant arable crops will be increased from EUR 63 to EUR 66/t. These will be included in the single farm payment. (Please refer to CNS/2003/0006). The proposals also deal with import duty within the WTO provisions, export refunds and licences, and other matters consequent on a common market in cereals.

2003/0008(CNS) - 29/09/2003 - Final act

PURPOSE: to repeal and replace Regulation 1766/92/EC on the common organisation of the market in cereals. LEGISLATIVE ACT: Council Regulation 1784/2003/EC on the common organisation of the market in cereals. CONTENT: the Council formally adopted the Regulations on reform of the Common Agricultural Policy, without debate and by a qualified majority, the Portuguese delegation voting against the "horizontal" Regulation and the Regulation establishing a levy in the milk and milk products sector. Statements by the Council, Belgium, France, the Netherlands, Luxembourg, Austria, Finland, the United Kingdom, Portugal (giving reasons for voting against) and the Commission are appended to the legal texts adopted. Initially based on principles (Articles 32 to 38 of the Treaty) intended to ensure self-sufficiency in food for the European Community by increasing agricultural productivity, to guarantee a high income to farmers, to stabilise markets and to provide agricultural products at a reasonable price to consumers, the reformed CAP henceforth introduces a new key element, a pillar of the reform, which is the partial decoupling of production-related aid, based on a

reference period (2000-2002); it now makes payment of such aid conditional on compliance with rules on the environment, animal welfare, hygiene standards and preservation of the countryside. The key elements of the new, reformed CAP in a nutshell: - a single farm payment for EU farmers, independent from production; limited coupled elements may be maintained to avoid abandonment of production, - this payment will be linked to the respect of environmental, food safety, animal and plant health and animal welfare standards, as well as the requirement to keep all farmland in good agricultural and environmental condition ("cross-compliance"), - a strengthened rural development policy with more EU money, new measures to promote the environment, quality and animal welfare and to help farmers to meet EU production standards starting in 2005. - a reduction in direct payments ("modulation") for bigger farms to finance the new rural development policy, - a mechanism for financial discipline to ensure that the farm budget fixed until 2013 is not overshot, - revisions to the market policy of the CAP: - asymmetric price cuts in the milk sector: The intervention price for butter will be reduced by 25% over four years, which is an additional price cut of 10% compared to Agenda 2000, for skimmed milk powder a 15% reduction over three years, as agreed in Agenda 2000, is retained, - reduction of the monthly increments in the cereals sector by half, the current intervention price will be maintained, - reforms in the rice, durum wheat, nuts, starch potatoes and dried fodder sectors. As regards cereals, the current intervention price for cereals is maintained. The basic amount for arable crops remains EUR 63/t. The existing seasonal correction for intervention price ("monthly increments") will be reduced by 50%. To avoid a further accumulation of intervention stocks, rye will be excluded from the intervention system. To cushion adverse effects of the necessary restructuring, the following transitional measure willapply. For Member States where the rye production is higher than 5% of its total cereal production and 50% of the EU's total rye production, 90% of the modulation money stays in the country. At least 10% of this money has to be spent in rye producing regions. ENTRY INTO FORCE: 28 October 2003.

2003/0008(CNS) - 10/11/2006 - Implementing legislative act

ACT: to codify provisions on fixing and granting adjusted refunds on cereals exported in the form of certain spirit drinks.

CONTENT: in the interests of clarity and rationality this Act codifies provisions set out in Commission Regulation 2825/93/EEC laying down certain detailed rules for the application of Council Regulation 1766/92/EEC as regards the fixing and granting of adjusted refunds in respect of cereals exported in the form of certain spirit drinks.

The purpose of these Regulations is to set out detailed rules for fixing and granting export refunds for cereals exported in the form of spirit drinks and for which a compulsory ageing period of at least three years is part of the manufacturing process. The spirits referred to are set out in Article 16 of Regulation 1784/2003/EC and include Scotch whiskey, Irish whiskey and Spanish whiskey.

ENTRY INTO FORCE: 12 November 2006.
