## **Agricultural surveys in 2005 and 2007: structure of holdings of the new Member States (amend. Regulation (EEC) No 571/88)**

2003/0234(COD) - 22/06/2004 - Final act

**PURPOSE** : to set the maximum amounts of the Community contribution to be made towards the expenses incurred for the 2005 and 2007 agricultural surveys for the 10 acceding countries.

**LEGISLATIVE ACT** : Regulation 1435/2004/EC of the European Parliament and of the Council amending, as a result of enlargement, Council Regulation 571/88/EEC on the organisation of Community surveys on the structure of agricultural holdings.

**CONTENT** : this Regulation, which incorporates the amendments of the European Parliament, sets the maximum amounts of the Community contribution to be made towards the expenses incurred for the 2005 and 2007 surveys for the ten acceding countries, and also sets the financial framework for these countries for the period 2004-2006 at EUR 43.7 mio. Compared to the Commission proposal, where the financial framework for the period 2007-2009 was set in the proposal at EUR 29.3 mio, the amount for the period 2007-2009 will now be fixed by the budgetary and legislative authority on a proposal from the Commission on the basis of the new financial perspective for the period starting in 2007.

Lastly, the Member States have to conduct a survey on the structure of agricultural holdings in 2005 and 2007.

**ENTRY INTO FORCE** : 05/09/2004. Point 1 of Article 1 shall apply as from 01/05/2004.

## **Agricultural surveys in 2005 and 2007: structure of holdings of the new Member States (amend. Regulation (EEC) No 571/88)**

2003/0234(COD) - 21/04/2004 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted a resolution drafted by Reimer BöGE (EPP-ED, D) and made some amendments to the amounts in the financial framework for the period 2007-2009. These amounts were deleted, since Parliament stated that they would be fixed by the budgetary and legislative authority on a proposal from the Commission on the basis of the new financial perspective for the period commencing in 2007.

## **Agricultural surveys in 2005 and 2007: structure of holdings of the new Member States (amend. Regulation (EEC) No 571/88)**

2003/0234(COD) - 15/10/2003 - Legislative proposal

**PURPOSE** : to amend Council Regulation 571/88/EEC on the organisation of Community surveys on the structure of agricultural holdings.

**PROPOSED ACT** : Regulation of the European Parliament and the Council. **CONTENT** : in accordance with Council Regulation 571/88/EC, as last amended by Commission Regulation 143/2002/EC, the Member States shall be required to conduct a survey on the structure of agricultural holdings in 2005 and 2007, as part of the multiannual programme of surveys covering the period to 2007. Article 14 of this Regulation provides that the Member States shall be reimbursed "20 ECU per holding for the expenses incurred in carrying out the surveys, subject to a maximum amount per survey". The proposed Regulation establishes the maximum Community contribution for the 2005 and 2007 surveys to be carried out in Cyprus, the Czech Republic, Estonia, Hungary, Latvia, Lithuania, Malta, Poland, the Slovak Republic and Slovenia. These maximum amounts have been determined on the basis of the number of agricultural holdings and the surface area of the countries concerned, in such a way as to ensure that these countries are treated in a comparable manner to the current Member States. Moreover, as this is a multiannual programme which will be adopted under the co-decision procedure in accordance with the Interinstitutional Agreement of 6 May 1999, the proposed Regulation lays down the financial framework for the remainder of the programme. **FINANCIAL IMPLICATIONS** : - Budget line : 50802 (ex B2-5121) : Surveys on the structure of agricultural holdings; - Total allocation for the action EUR 73 000 000 of which EUR43 700 000 for the period 2004-2006 and EUR 29 300 000 for the period 2007-2009.
