Air transport sector: application of Article 81(3) of the Treaty to certain categories of agreements and concerted practices (repeal. Regulation (EEC) No 3976/87). Codification

2008/0124(CNS) - 17/06/2008 - Legislative proposal

PURPOSE: to codify Council Regulation (EEC) No 3976/87 as regards certain categories of agreements and concerted practices in the air transport sector.

PROPOSED ACT: Council Regulation.

CONTENT: the purpose of this proposal is to undertake a codification of Council Regulation (EEC) No 3976/87 on the application of Article 85(3) of the Treaty to certain categories of agreements and concerted practices in the air transport sector. The new Regulation will supersede the various acts incorporated in it. This proposal fully preserves the content of the acts being codified and hence does no more than bringing them together with only such formal amendments as are required by the codification exercise itself.

The codification proposal was drawn up on the basis of a preliminary consolidation, in all official languages, of Regulation (EEC) No 3976/87 and the instruments amending it, carried out by the Office for Official Publications of the European Communities, by means of a data-processing system. Where the Articles have been given new numbers, the correlation between the old and the new numbers is shown in a table contained in Annex II to the codified Regulation.

PURPOSE: to codify Council Regulation (EEC) No 3976/87 as regards certain categories of agreements and concerted practices in the air transport sector.

LEGISLATIVE ACT: Council Regulation (EC) No 487/2009 on the application of Article 81(3) of the Treaty to certain categories of agreements and concerted practices in the air transport sector (Codified version).

CONTENT: the purpose of this Regulation is to undertake a codification of Council Regulation (EEC) No 3976/87 of 14 December 1987 on the application of Article 85(3) of the Treaty to certain categories of agreements and concerted practices in the air transport sector. This new Regulation will supersede the various acts incorporated in it. It fully preserves the content of the acts being codified and hence does no more than bringing them together with only such formal amendments as are required by the codification exercise itself.

ENTRY INTO FORCE: 01/07/2009.

2008/0124(CNS) - 21/10/2008 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted, by 655 votes to 13 with 19 abstentions, under the consultation procedure, a legislative resolution approving the proposal for a Council regulation on the application of Article 81(3) of the Treaty to certain categories of agreements and concerted practices in the air transport sector (codified version). The report had been tabled for consideration in plenary by Diana **WALLIS** (ALDE, UK) on behalf of the Legal Affairs Committee. The Commission proposal was approved as adapted to the recommendations of the Consultative Working Party of the Legal Services of the European Parliament, the Council and the Commission.
