2009/2047(BUD) - 15/09/2009 - Budgetary text adopted by Parliament

The European Parliament adopted, by 600 votes to 8, with 33 abstentions, a resolution approving, unamended, the draft amending budget No 6/2009.

Parliament recalls that the sole purpose of this draft amending budget is to incorporate formally the following technical adjustments into the 2009 budget:

- the revision of the forecast of traditional own resources as well as the Value-added Tax (VAT) and Gross National Income (GNI) bases;
- the budgeting of the relevant UK corrections as well as their financing;
- the revision of financing of GNI reductions in favour of the Netherlands and Sweden in 2009.

PURPOSE: final adoption of amending budget 6/2009.

LEGISLATIVE ACT: 2009/801/EC, Euratom.

CONTENT: the European Parliament has adopted amending budget No 6 to the European Union for the financial year 2006 in accordance with its resolution of 15 September (please refer to the summary of the resolution).

This amending budget covers:

- the revision of the forecast of Traditional Own Resources (TOR, i.e. customs duties and sugar levies), VAT and GNI bases,
- the budgeting of the relevant UK corrections as well as their financing,
- the revision of financing of GNI reductions in favour of the Netherlands and Sweden in 2009.

2009/2047(BUD) - 18/06/2009 - Commission preliminary draft budget

PURPOSE: to present the Preliminary Draft Amending Budget No 6 to the Budget for 2009 (PDAB 6/2009).

CONTENT: the Preliminary Draft Amending Budget No 6 to the Budget for 2009 covers:

- the revision of the forecast of Traditional Own Resources (TOR, i.e. customs duties and sugar levies), VAT and GNI bases,
- the budgeting of the relevant UK corrections as well as their financing,
- the revision of financing of GNI reductions in favour of the Netherlands and Sweden in 2009, resulting in a change in the distribution between Member States of their own resources contributions to the EU budget.

2009/2047(BUD) - 13/07/2009 - Council draft budget

On 19 June 2009, the Commission forwarded to the Council preliminary draft amending budget (PDAB) No. 6/2009. This PDAB covers the revision of the forecast of traditional own resources (TOR, i.e. customs duties and sugar levies), VAT and GNI bases, the budgeting of the relevant UK corrections as well as their financing and the revision of financing of GNI reductions in favour of the Netherlands and Sweden in 2009.

The result is a change in the distribution between Member States of their own resources contributions to the EU budget.

On 13 July 2009, the Council established draft amending budget No. 6 for the financial year 2009, as submitted by the Commission in its preliminary draft amending budget No. 6 and as set out in the technical annex to the explanatory memorandum of this Council draft budget (see *Council doc. 11888 /09 ADD 1*).
