## Court of Auditors: appointment of a member, Jan Kinst (CZ)

2010/0803(NLE) - 26/04/2010 - Final act

PURPOSE: to appoint a member of the Court of Auditors.

LEGISLATIVE ACT: Council Decision 2010/246/EU appointing nine members of the Court of Auditors.

CONTENT: under this Decision, Mr Jan KINŠT is appointed member of the Court of Auditors for the period from 7 May 2010 to 6 May 2016.

2010/0803(NLE) - 25/03/2010 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 558 votes to 8 with 48 abstentions a decision delivering a favourable opinion on the nomination of Jan Kinšt (CZ) as a Member of the Court of Auditors.
