## Court of Auditors: appointment of a member, Leonard Orban - RO

2012/0805(NLE) - 01/10/2012 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Budgetary Control adopted the report by Inés AYALA SENDER (S&D, ES), and called upon the European Parliament to **deliver a negative opinion on the Council's nomination of Leonard Orban as a Member of the Court of Auditors.**

Parliament's Committee on Budgetary Control had evaluated the credentials of Mr Orban, in view of the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union.

## Court of Auditors: appointment of a member, Leonard Orban - RO

2012/0805(NLE) - 23/10/2012 - Text adopted by Parliament, 1st reading/single reading

The European Parliament decided to deliver a negative opinion on the Council's appointment of **Leonard ORBAN** as a Member of the Court of Auditors.

Mr ORBAN's candidacy was rejected by the European Parliament by 294 votes to 269, with 80 abstentions.
