## Court of Auditors: appointment of a member, Klaus-Heiner Lehne - DE

2013/0813(NLE) - 04/02/2014 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 457 votes to 169, with 55 abstentions, a decision in which it delivered a **favourable opinion** on the Council's nomination of Klaus Heiner LEHNE (DE) as a Member of the Court of Auditors. The credentials of the nominee fulfilled the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union (TFEU).

The Committee on Budgetary Control adopted the report by Inés AYALA SENDER (S&D, ES).

It called on the European Parliament to deliver a favourable opinion on the Council's nomination of **Klaus Heiner Lehne** (DE) as a Member of the Court of Auditors.

At its meeting of 23 January 2014, the Committee on Budgetary Control heard the Council's nominee for membership of the Court of Auditors. Following this hearing, the Budget Control Committee considered that the nominee fulfilled the requirements laid down in Article 286(1) of the Treaty on the Functioning of the European Union (TFEU).
