Appointment of the Chairperson of the European Statistical Governance Advisory Board (ESGAB)

2014/0810(NLE) - 13/01/2015 - Legislative proposal

PURPOSE: to appoint the Chairperson of the European Statistical Governance Advisory Board.

PROPOSED ACT: Council Decision.

ROLE OF THE EUROPEAN PARLIAMENT: the Council adopts the act after consulting the European Parliament but without being obliged to follow its opinion.

BACKGROUND: on 24 January 2012, the Council adopted Decision 2012/42/EU appointing Mr Thomas WIESER as the Chairperson of the European Statistical Governance Advisory Board for a period of three years from 23 March 2012.

It is therefore necessary to appoint a new Chairperson to take office upon expiry of the term of office which began on 23 March 2012.

CONTENT: it is proposed that Mr. Martti HETEMÄKI be appointed Chairperson of the European Statistical Governance Advisory Board for a period of three years from 1 February 2015.

Appointment of the Chairperson of the European Statistical Governance Advisory Board (ESGAB)

PURPOSE: to appoint the Chairperson of the European Statistical Governance Advisory Board.

NON-LEGISLATIVE ACT: Council Decision appointing the Chairperson of the European Statistical Governance Advisory Board.

CONTENT: the Council decided to appoint **Martti HETEMÄKI** as Chairperson of the European Statistical Governance Advisory Board for a period of 3 years from 1 February 2015.

Thomas WIESER was appointed as the Chairperson of the European Statistical Governance Advisory Board for a period of 3 years from 23 March 2012.

In order to harmonise the terms of office of all new board members, it was decided that the term of office the new Chairperson should begin on 1 February 2015.
