## EC/Bosnia and Herzegovina Stabilisation and Association Agreement: accession of Croatia to the EU. Protocol

2016/0311(NLE) - 20/06/2017 - Final act

**PURPOSE:** to conclude a Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of Croatia's accession to the European Union.

**NON-LEGISLATIVE ACT:** Council Decision (EU) 2017/1163 on the conclusion, on behalf of the Union and its Member States, of the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of Croatia to the European Union.

**BACKGROUND:** In accordance with Council Decision (EU) 2017/75, the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part taking into account the accession of Croatia to the European Union, was signed on 15 December 2016, subject to its conclusion.

The Protocol should now be approved.

**CONTENT:** with this Decision, the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the Accession of Croatia to the European Union is hereby approved on behalf of the Union and its Member States.

**ENTRY INTO FORCE:** the Decision shall enter into force on 20.6.2017. The date of entry into force of the Protocol will be published in the *Official Journal of the European Union* by the General Secretariat of the Council.

**PURPOSE:** to conclude a Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of Croatia to the European Union.

**PROPOSED ACT:** Council Decision.

**ROLE OF THE EUROPEAN PARLIAMENT:** the Council adopts the act after consulting the European Parliament but without being obliged to follow its opinion.

**BACKGROUND:** the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of Croatia to the European Union was signed, subject to its conclusion. The Protocol should now be approved.

**CONTENT:** the draft Council decision is aimed at **approving, on behalf of the Union**, the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of Croatia to the European Union.

In terms of the Protocol, Croatia shall be Party to the SAA, signed in Luxembourg on 16 June 2008, and shall respectively adopt and take note, in the same manner as the other Member States of the European Union, of the texts of the SAA, as well as of the Joint Declarations, and the Unilateral Declarations annexed to the Final Act signed on the same date.

The adjustments to the text of the SAA relate to agricultural products (agricultural products sensu strictu, fish and fishery products, processed agricultural products and wine agreement.)

The conclusion of the Protocol is subject to a separate procedure as regards matters falling within the competence of the European Atomic Energy Community.

2016/0311(NLE) - 21/04/2017 - Committee report tabled for plenary, 1st reading/single reading

The Committee on Foreign Affairs adopted the report by Cristian Dan PREDA (EPP, RO) on the draft Council decision on the conclusion, on behalf of the Union and its Member States, of the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of Croatia to the European Union.

The committee recommended the European Parliament to **give its consent** to the conclusion of the Agreement.

## **EC/Bosnia and Herzegovina Stabilisation and Association Agreement: accession of Croatia to the EU. Protocol**

2016/0311(NLE) - 16/05/2017 - Text adopted by Parliament, 1st reading/single reading

The European Parliament adopted by 592 votes to 54, with 21 abstentions, a resolution on the draft Council decision on the conclusion, on behalf of the Union and its Member States, of the Protocol to the Stabilisation and Association Agreement between the European Communities and their Member States, of the one part, and Bosnia and Herzegovina, of the other part, to take account of the accession of the Republic of Croatia to the European Union.

The European Parliament **gave its consent** to the conclusion of the Agreement.
