The Commission proposed granting aid, for the 1994 harvest, to Community hop producers for the growing of aromatic, bitter and other varieties, as well as for experimental stocks. Compared to the 1993 harvest, this proposal provided for an increase in the average level of aid granted to producers for aromatic and bitter variety categories, and a slight decrease for the "other varieties" category, including experimental varieties. ?
