EC/Turkey: negotiation and conclusion of an agreement on the Customs Union

OBJECTIVE: implementation of the final stage of the Customs Union with Turkey. **SUBSTANCE:** on 6 March 1995, the EC-Turkey Association Council gave its agreement in principle on the decision implementing the final phase of the Customs Union with Turkey. The European Parliament was now requested to give its assent to this draft decision, which took the form of a common position of the Community within the EC-Turkey Association Council. The main characteristics of this agreement were as follows: - the establishment of 1 January 1996 as the date for the definitive completion of the Customs Union including all the relevant technical aspects: . the free movement of goods and the elimination of customs duties and taxes with equivalent effect after this date and quantitative restrictions on the import and export of goods by both parties; gradual transposition by Turkey of Community legislation on the abolition of technical barriers to trade and on product conformity with EC legislation requirements; . commercial policy: implementation of measures that were substantially similar to those of the Community's commercial policy; . extension of the CCT to include Turkey and granting of tariff preferences (except for certain products agreed by the Association Council up to 1 January 2001); . temporary derogation for the dismantling of tariffs for certain processed agricultural products listed in Annex I to the Decision; - protection of intellectual, industrial and commercial property (implementation of the TRIPS agreement no later than three years after the entry into force of the Customs Union); - respect for the competition principles that characterised the Community, together with the gradual harmonisation of Turkish legislation in this area with the *acquis communautaire*; - fixing of the earliest date possible after the entry into force of the Customs Union for the opening up of the parties' respective government procurement markets. The decision also included: . institutional provisions (establishment of a EC-Turkey Customs Union Joint Committee to ensure the proper functioning of the agreement), . provisions relating to the settlement of disputes, . a safeguard clause. ?

By 343 votes to 149 and 36 abstentions, Parliament adopted the report by Mr CARNERO GONZALEZ (GUE, E), thus giving assent to the Customs Union agreement between the European Union and Turkey. ?

EC/Turkey: negotiation and conclusion of an agreement on the Customs Union

The rapporteur, Mr CARNERO GONZALEZ (GUE/NGL, E), stated that at the present moment in time Turkey was still not a democratic state. In 1995 human rights violations, executions, arbitrary arrests and torture reached their highest levels in Turkey. The rapporteur therefore feared that if the EP voted in favour of this proposal it could be interpreted as support for the conservative powers that did not want any changes; he therefore did not support moving to the final phase of the customs union between the EU and Turkey. Pointing out that the winner of the Sakharov Prize, Mrs Leyla ZANA, could not be present in the Hemicycle because she was being held in a Turkish prison, Mr CARNERO GONZALEZ stated that Turkey had not fulfilled the minimum conditions imposed by the European Parliament itself for ratification of the customs union. Other Members also opposed ratification, including Mr PUERTA, on behalf of the GUE/NGL Group, Mr SOUCHET, on behalf of the EDN Group, Mr SCHULZ, on behalf of the PSE members who disagreed with the majority who were in favour of ratification, and Mrs ROTH, who, on behalf of the Greens, proposed postponing the vote. Commissioner van den Broek stated that the Commission and the Council believed that the customs union would help the democratisation process and that they should not underestimate the efforts of the Turkish authorities to show their commitments in this respect. He also stressed that there was the risk of an upsurge in Islamic fundamentalism if ratification did not take place. For all of these reasons, the Council and the Commission urged Parliament to ratify the agreement in order to show its support for the reforms undertaken by the Turkish authorities and its solidarity with the Turkish people.

EC/Turkey: negotiation and conclusion of an agreement on the Customs Union

PURPOSE: the putting in place of the Customs Union with Turkey. COMMUNITY MEASURE: Decision 1/95 of the EC-Turkey Association Council of 22 December 1995 on implementing the final phase of the Customs Union (96/142/EEC). CONTENT: The main provisions of this Council Decision are the following: - The free movement of goods and commercial policy. Products from third countries shall be considered to be in free circulation in the Community or in Turkey if the import facilities have been complied with and any custom duties or charges having equivalent effect which are payable have been levied in the Community or in Turkey, and if they have not benefited from a total or partial reimbursement of such duties or charges; - Elimination of customs duties and charges having equivalent effect. Customs duties shall be wholly abolished between the Community and Turkey on the date of entry into force of this Decision. Also, the Community and Turkey shall refrain from introducing any new customs duties on imports or exports or any charges having equivalent effect from that date; - Elimination of quantitative restrictions or measures having equivalent effect; - After entry into force of this Decision, Turkey shall, in relation to countries which are not members of the Community, apply provisions and implementing measures which are substantially similar to those of the Community's commercial policy; - Upon entry into force of this Decision, Turkey shall, in relation to countries which are not members of the Community, align itself to the Common Customs Tariff; - Processed agricultural products not covered by Annex II of the Treaty establishing the European Community; - Approximation of laws. This relates to the protection of intellectual, industrial and commercial property as well as competition rules. - Approximation of legislation. This relates to trade defence instruments, government procurement, direct taxation and indirect taxation. - Institutional provisions. This relates to the EC-Turkey Customs Union Joint Committee, consultation and decision procedures, settlement of disputes and safeguard measures. ENTRY INTO FORCE: This Decision shall enter into force on 31.12.1995.?
