- OBJECTIVE: the proposal for a decision seeks to extend the time-limit for implementing certain pilot projects on continuous position monitoring of Community fishing vessels, and the Community contribution to the expenditure incurred in their implementation. - SUBSTANCE: . an additional period to be granted to certain Member States (up to 31.12.1995) to complete their pilot projects so that they can be of greatest use; . deferral to 01.07.1996 of the date on which the Council will decide on the application of the continuous position monitoring system, whether land or satellite-based and using satellite communications for data transmission; . adjustment of the period laid down in Decision 89/631/EEC on a Community financial contribution towards expenditure incurred for the purpose of ensuring compliance with the Community system for the conservation and management of fishery resources (31.12.1995); . extension of the time-limit (to 30.04.1996) by which Member States must submit applications for reimbursement of expenditure incurred when implementing the above pilot projects. ?

## Continuous position monitoring of Cummunity fishing vessels (amend. Regul. 2847/93/EEC and dec. 89/631/EEC)

The Council adopted the Decision that would extend the time limit for implementing certain pilot projects on continuous position monitoring of Community fishing vessels, whether land- or satellite-based, in connection with the control system applicable to the common fisheries policy. The time limit by which Member States must submit applications for reimbursement of expenditure on implementing the pilot projects is consequently extended.
