Coordination of activities in favour of SMEs and the craft sector

OBJECTIVE: to present, in accordance with Article 5 of Council Decision 93/379/EEC, the coordination between action taken under enterprise policy and action taken under other Union policies. CONTENT: the Commission concludes its report by stating that it will continue efforts to achieve internal coordination so that its policies help to support the development of SMEs. It states that SMEs are now properly targeted in almost all Community programmes. The report shows that significant progress has been made in the area of the Structural Funds, especially through the SME Community initiative, RDT and vocational training (Objective 4 of the Structural Funds, ADAPT initiative, LEONARDO programme). The Commission must ensure that it monitors the implementation of programmes so that the objectives set out are translated into concrete results for SMEs. The enterprise policy services are cooperating with all the other services in both the design and implementation of programmes and policies. The efforts made so far need to be continued in order to make these programmes more visible and efficient. The Commission will step up efforts to coordinate with all its partners, the Member States, the European institutions and professional associations so that action to help SMEs translates into growth, competitiveness and jobs.?

Coordination of activities in favour of SMEs and the craft sector

The Committee adopted the report on the future SME and craft industry policy drafted by Mr Riccardo GAROSCI (UfE, I), largely supports the efforts of the Commission to improve coordination between different Community initiatives in favour of SMEs. The report call for a broad range of range of measures to improve the situation for SMEs, in particular by putting the political will to support SMEs into action by stepping up financial support to this sector, such as the Elise scheme for loan guarantees which is currently blocked in the Council. The main theme of the report is the need to lighten the heavy administrative burdens that the SMEs have to carry and to involve SMEs in the EU decision-making mechanisms to a greater extent. ?

Coordination of activities in favour of SMEs and the craft sector

Adopting the report by Mr Riccardo GAROSCI (UPE, I), the European Parliament broadly approved the efforts made by the Commission to increase coordination amongst the various Community initiatives launched for the benefit of SMEs. Parliament stressed the need for current and future legislation to be simplified and the need for tax benefits to be granted to labour-intensive SMEs, particularly in the services sector. It hoped that the banking and credit sectors would grant facilities to all SMEs, particularly by means of a code of banking practice in respect of SMEs. Parliament called on the Commission to boost the projects aimed at facilitating participation by SMEs in the EC environmental audit scheme and urged that SMEs should be directly involved in decisions, in particular through involvement on the part of the associations which represent them.
