Export of cultural goods (amend. annex Regul. 3911/92/EEC)

OBJECTIVE: to amend Regulation No 3911/92/EEC on the export of cultural goods, with a view to solving the problem of watercolour, gouache and pastel pictures, which are classified in the Regulation both as paintings and as drawings. SUBSTANCE: for the purposes of Regulation No 3911/92/EEC, works done using watercolours, gouaches and pastels are to be classified either as paintings or as drawings, corresponding to categories 3 and 4 of the Regulation respectively. However, different financial thresholds apply to each of these categories and this could lead to serious differences of treatment of such works depending upon in which Member State they are situated and the differing national artistic traditions (which attach more or less value to one or another type of production). To resolve this problem, the Commission proposes determining which category such works belong to by creating a new separate category with a threshold of ECU 30 000, thus ensuring that: - on the one hand, works of this type that are of major significance will obtain an export licence, - on the other hand, any undue administrative load for the licencing authorities is avoided (too many export licences could in fact be issued despite the fact that this type of work is not always of significant market value). ?

Export of cultural goods (amend. annex Regul. 3911/92/EEC)

The Committee approves the proposed specific, limited amendments to the Annexes, insofar as they are designed to bring about greater legal certainty in respect of the implementation of the EU provisions. With a view to the three-yearly review of both the Regulation and the Directive 93/7/EEC - due to be carried out in 1996 - and in the light of the implementation reports provided for in Article 10 of the Regulation and Article 16 of the Directive, the Committee does, however, wish to take this opportunity to call upon the Commission to attach especial importance to the following: - the level of implementation of the Regulation and the Directive in the various Member States; - the advisability of introducing a form of "passport" or accompanying certificate for particular works of art; - increased cooperation between police forces and legal authorities in the field of the identification of stolen or unlawfully exported cultural goods. On a more general note, the Committee gives its backing to all endeavours to safeguard the immense heritage of cultural goods in the EU; these cultural goods are an integral part of Europe's history and its different cultures.?

Export of cultural goods (amend. annex Regul. 3911/92/EEC)

In adopting the report by Mr José Antonio ESCUDERO (PPE, E) on the return of cultural objects unlawfully removed from the territory of a Member State, the European Parliament approved the Commission's proposal without amendments. ?

Export of cultural goods (amend. annex Regul. 3911/92/EEC)

OBJECTIVE: to amend Council Regulation (EEC) No 3911/92 on the export of cultural goods, with a view to solving the problem of water colours, pastels and gouaches, which are classified, in the Regulation, both as paintings and as drawings. COMMUNITY MEASURE: Council Regulation (EC) No 2469/96 amending the Annex to Council Regulation (EEC) No 3911/92 on the export of cultural goods. SUBSTANCE: for the purposes of Council Regulation (EEC) No 3911/92, works done using water colours, gouaches and pastels are to be classified either as paintings or as drawings, corresponding respectively to categories 3 and 4 of the Regulation. However, for each of these categories, different financial thresholds are applicable, which could lead to serious differences of treatment of such works depending upon in which Member State they are situated and the differing national artistic traditions (which attach more or less value to one or another type of production). To avoid this problem, the Regulation finally settles the question as to which category such works should be put into by creating a new separate category with its own threshold of ECU 30 000, thus ensuring that: - works of major significance would require an export licence, - there would not be the creation of any undue administrative load placed upon the licencing authorities. ENTRY INTO FORCE: 27 December 1996. ?
