Veterinary controls: Annex A directive 89/662/EEC and direct. 90/675/EEC (amend. annex Direct. 85/73/EEC)

OBJECTIVE: to amend Directive 85/73/EEC laying down general rules with a view to financing veterinary inspections of Community animal products or those imported from third countries. CONTENT: the proposal for a Council directive states that, in the case of poultrymeat governed by Directive 71/118/EEC, last modified by the deed of accession of Austria, Finland and Sweden, the provisions concerning the minimum amount to be collected for ante-mortem and post-mortem inspections should be maintained.?

The Council adopted an amendment to the Annex to Directive 85/73/EEC on the financing of veterinary inspections and controls of animal products covered by Annex A to Directive 89/662/EEC and by Directive 90/675/EEC. ?

Veterinary controls: Annex A directive 89/662/EEC and direct. 90/675/EEC (amend. annex Direct. 85/73/EEC)

OBJECTIVE: to amend Directive 85/73/EEC laying down general rules with a view to financing veterinary inspections of Community animal products or those imported from third countries. COMMUNITY MEASURE: Council Directive 96/17/EC amending the Annex to Directive 85/73/EC on the financing of veterinary inspections and controls of animal products covered by Annex A to Directive 86/662/EEC and by Directive 90/675/EEC. SUBSTANCE: in the case of poultrymeat, the minimum amount to be collected for ante- and post-mortem inspections had been set at a fixed level until 31 December 1995. The Directive was intended to maintain the status quo ante until 30 June 1996. It accordingly stipulated that fees were chargeable to the operator or owner of an establishment, who was entitled to recover dues paid from the natural or legal person on whose behalf a measure had been carried out. ENTRY INTO FORCE: 29/03/1996. The Directive applies with effect from 1 January 1996. ?
