### Animal health conditions: imports from third countries of fresh poultry meat (amend. direct. 91/494/EEC)

- OBJECTIVE: to revise Directive 91/494/EEC on the veterinary rules governing intra-Community trade and third-country imports of fresh poultry products, in the light of the application of harmonized standards for vaccines against Newcastle disease. - SUBSTANCE: - The Council's proposal for a directive concerns the veterinary guarantees which apply to trade in poultry and poultry products from a Community area practising vaccination against Newcastle disease to areas where a status of non-vaccination applies (Denmark, Ireland, Northern Ireland, Finland and Sweden); - The proposal simplifies the veterinary health rules which apply, this simplification having been made possible by the application of harmonized standards for vaccines (Commission Decision 93/152/EEC). ?

### Animal health conditions: imports from third countries of fresh poultry meat (amend. direct. 91/494/EEC)

The ESC feels that the emphasis should be on working towards a uniform status for the whole EU, at a relatively high level, to end the division of the EU into a vaccinating area and a non-vaccinating area. It acknowledges that laying down criteria for the use of vaccines against Newcastle disease will ensure that live, attenuated and inactivated vaccines fulfil certain conditions. On imports of poultry and poultry products from third countries, the ESC feels that it is crucial that such imports should not pose a threat to existing veterinary and animal health rules in the EU. It endorses the proposal that the Commission should have the option of imposing quarantine or isolation for two months in the case of poultry, hatching eggs or chicks from these eggs.?

### Animal health conditions: imports from third countries of fresh poultry meat (amend. direct. 91/494/EEC)

In adopting the report by Mr Horst SCHNELHARDT (PPE, D), Parliament approved the proposal to amend a directive with a single amendment. It called on the Member States to comply with the Directive before 31 December 1996 (instead of 31 December 1995). ?

PURPOSE : to revise Directive 91/494/EEC on the veterinary rules governing intra-Community trade and third country imports of fresh poultry products, in light of the application of harmonized standards for vaccines against Newcastle disease. COMMUNITY MEASURE : Council Directive 1999/89/EC amending Directive 91/494/EEC on animal health conditions governing intra-Community trade in and imports from third countries of fresh poultry meat. CONTENT : this Directive concerns the veterinary guarantees which apply to trade in poultry products from a Community area practising vaccinations against Newcastle disease to areas where a status of non-vaccination applies (Denmark, Ireland, Northern Ireland, Finland and Sweden. In addition, the Directive simplifies the veterinary health rules which apply, this simplification having been made possible by the application of harmonized standards for vaccines. ENTRY INTO FORCE : 23/11/1999. DEADLINE FIXED FOR THE TRANSPOSITION : 01/07/2000.?
