- OBJECTIVE: to increase by 10,000 tonnes the sugar production quotas for Portugal in order to permit a start on sugar production in that country, as laid down in the Act of Accession. - SUBSTANCE: The Commission proposed the following increase in the basic A and B sugar quantities established for Portugal (mainland): - Basic quantity A: 63,636.4 t. (current level: 54,545.5 t.); - Basic quantity B: 6,363.6 t. (current level: 5,454.5 t.). ?
