Guarantee thresholds for leaf tobacco by group of tobacco varieties for the 1996 and 1997 harvests (regul. 2075/92/EEC)

- OBJECTIVE: to set the guarantee thresholds for leaf tobacco by tobacco variety group for the 1996 and 1997 harvests. - SUBSTANCE: the proposed amendment of Regulation 2075/92/EEC aims to permit Member States to transfer quantities of their guarantee threshold from one variety group to other groups, while ensuring that any resulting increase in the guarantee threshold for one variety group does not entail additional expenditure under the EAGGF. The measure introduces a degree of flexibility into the management of the guarantee threshold.?

Guarantee thresholds for leaf tobacco by group of tobacco varieties for the 1996 and 1997 harvests (regul. 2075/92/EEC)

In adopting the report by Mrs Irini LAMBRAKI (PSE, Gr), Parliament proposed that the transfer of guarantee threshold quantities from one group of tobacco varieties to another should not give rise to additional expenditure for the EAGGF of more than 5% over the previous year.?

Guarantee thresholds for leaf tobacco by group of tobacco varieties for the 1996 and 1997 harvests (regul. 2075/92/EEC)

The ESC takes the view that the Commission proposal on the guaranteed thresholds for 1996 and 1997 is a step in the right direction, but the delay for the 1996 financial year is now unavoidable. It feels that, if market conditions require revision of the thresholds for 1997, the decision-making procedure will have to be completed by 31 December 1996 to allow quotas to be allocated to producers in good time. The ESC believes that the new Commission proposal on future policy in the tobacco sector (to be submitted before 1 April 1996) will need to tackle the sector as a whole with a view to adapting production to market needs, improving quality and organization, taking account of the role and importance of tobacco-growing for the economy and social fabric of certain EU regions, as well as application of the Community preference.?

Guarantee thresholds for leaf tobacco by group of tobacco varieties for the 1996 and 1997 harvests (regul. 2075/92/EEC)

The Council adopted a Regulation amending Regulation (EEC) No 2075/92 on the common organization of the market in raw tobacco. Article 9 of that Regulation provides that for each harvest, on a proposal from the Commission and after consulting the European Parliament, the Council shall allocate among producer Member States the quantities of raw tobacco available for each group of varieties?

Guarantee thresholds for leaf tobacco by group of tobacco varieties for the 1996 and 1997 harvests (regul. 2075/92/EEC)

OBJECTIVE: to set the guarantee thresholds for leaf tobacco by tobacco variety group for the 1996 and 1997 harvests. COMMUNITY MEASURE: Council Regulation (EC) No 415/96 amending Regulation (EEC) No 2075/92. SUBSTANCE: the Council Regulation lays down the guarantee thresholds by tobacco variety group and Member State for the 1996 and 1997 harvests. It introduces a measure of flexibility into the management of the guarantee threshold to the extent that Member States are permitted to transfer quantities of their guarantee threshold from one variety group to other groups but must ensure that any resulting increase in the guarantee threshold for a variety group does not entail additional expenditure under the EAGGF.
