Technical measures for the conservation of fishery resources in the Mediterranean

OBJECTIVE: to introduce into Council Regulation (EC) No 1626/94 the recommendation concerning the management of bluefin tuna in the Mediterranean, adopted by the General Fisheries Council for the Mediterranean (GFCM) at its session from 22 to 26 May 1995. The GFCM's recommendations will be binding upon its members (i.e. the four countries facing the Mediterranean: Greece, Spain, France and Italy). SUBSTANCE: the only amendment to the current legislation concerns the introduction of an annual period during which fishing is prohibited: It is prohibited to fish for bluefin tuna from vessels greater than 24 m in overall length during the period from 1 June to 31 July each year.?

The Committee approves the Commission proposal which it believes will promote a rational fisheries policy in keeping with resources.?

Technical measures for the conservation of fishery resources in the Mediterranean

The report by Mr BALDARELLI has been adopted. The Commission proposal aimed to bring Community legislation into line with decisions taken at the 21st ordinary meeting of the General Fisheries Council for the Mediterranean (GFCM) in May 1995, by introducing a ban on fishing for bluefin tuna for a certain period each year. The Committee adopted a single amendment to the draft regulation calling for a study to consider an all year long ban on sports fishing and, as a temporary measure, for fish to be considered undersize if their dimensions are less than the minimum specified in Annex IVa for the relant species. ?

In adopting the BALDARELLI report, the European Parliament approved the proposal for a regulation and called on the Commission to carry out a study on the effects of game fishing of bluefin tuna in the Mediterranean using fishing gear linked to aerial reconnaissance devices. ?

OBJECTIVE: to amend Regulation (EC) No 1626/94 by incorporating the recommendation on bluefin tuna management in the Mediterranean,

adopted by the General Fisheries Council for the Mediterranean at its session of 22 to 26 May 1995. COMMUNITY MEASURE: Council Regulation (EC) No 1075/96 amending Regulation (EC) No 1626/94 laying down certain technical measures for the conservation of fishery resources in the Mediterranean. SUBSTANCE: vessels of an overall length exceeding 24 m are prohibited under the Regulation from fishing for bluefin tuna with surface-set longlines from 1 June to 31 July each year. ENTRY INTO FORCE: 22/06/1996. ?
