Dangerous substances: classification, packaging and labelling (amend. Directive 67/548/EEC)

OBJECTIVE: amending for the eighth time Council Directive 67/548/EEC on the classification, packaging and labelling of dangerous substances, with a view to replacing the abbreviation 'EEC' with the abbreviation 'EC'. SUBSTANCE: - In Directive 67/548/EEC, the terms 'EEC number' and 'EEC label' are replaced by the terms 'EC number' and 'EC label' respectively; - However, Member States shall authorize the placing on the market of substances whose labels bear the 'EEC number' and the words 'EEC label' until 31 December 2000. ?

The European Parliament approved the proposal. ?

Although the proposed amendment addresses a purely formal/routine aspect of the issue - terminology - it is a legal requirement. The Commission proposal is however belated to say the least: the Maastricht Treaty was signed on 7 February 1992.?

Dangerous substances: classification, packaging and labelling (amend. Directive 67/548/EEC)

The common position of the Council made two changes in relation to the text proposed by the Commission: - a change of wording: the Member States would 'permit' (rather than 'authorize') the placing on the market, until 21/12/2000, of substances labelled with the 'EEC number' and the words 'EEC label'; - an extension of the deadline for transposition of the Directive: 01/06/1998 (instead of 01/06/1997). ?

The European Parliament approved the common position unamended (procedure without report).?

Dangerous substances: classification, packaging and labelling (amend. Directive 67/548/EEC)

The Council adopted the proposal for a directive, Parliament having tabled no amendments to the common position.

Dangerous substances: classification, packaging and labelling (amend. Directive 67/548/EEC)

OBJECTIVE: further amending Directive 67/548/EEC relating to the classification, packaging and labelling of dangerous substances, with a view to replacing the initials 'EEC No' with the initials 'EC'. COMMUNITY MEASURE: Directive 96/56/EC of the European Parliament and the Council. SUBSTANCE : In Directive 67/548/EEC, the term 'EEC No' and the term 'EEC label' are replaced by the term 'EC number' and the term 'EC label'. However, Member States will permit the placing on the market of dangerous substances whose labels bear the 'EEC No' and the words 'EEC label' until 31 December 2000. DATE OF ENTRY INTO FORCE: 21 September 1996. DEADLINE FOR TRANSPOSITION INTO NATIONAL LEGISLATION: 1 June 1998.?
