Conservation of fishery resources: the Baltic Sea, the Belts and the Sound (amend. Regulation (EEC) No 1866/86)

OBJECTIVE : to apply, from 1996, certain technical measures adopted by the International Baltic Sea Fishery Commission (IBSFC), a body which fixes the rules for conserving and managing fishery resources and which each year recommends catch ceilings and measures to ensure the conservation and responsible exploitation of such resources. SUBSTANCE : it is proposed to amend for the sixth time Regulation (EEC) No 1866/96 laying down, as from 1996, certain technical measures adopted at the most recent annual session of the IBSFC and which concern the closed season for fishing cod, salmon and sea trout. ?

Conservation of fishery resources: the Baltic Sea, the Belts and the Sound (amend. Regulation (EEC) No 1866/86)

The committee adopted the draft legislative resolution. The amendments to the Commission proposal relate to the quota system for cod from the Baltic Sea, which had not functioned as intended. The report called on the Commission to undertake a study on the feasibility of replacing the current quota system for cod by fixing a limit on the engine power for fishing boats, with a transitional period for the traditional fishermen in the Baltic Sea. ?

OBJECTIVE: In adopting the report by Mr Niels Anker KOFOED (ELDR, DK), on the proposal for a Council Regulation amending for the 6th time Regulation (EEC) No. 1866/86 laying down certain technical measures for the conservation of fishery resources in the waters of the Baltic Sea, the Belts and the Sound, Parliament did not go along with the Committee on Fisheries and rejected the two amendments adopted by the latter. ?

The Council adopted the Regulation.

Conservation of fishery resources: the Baltic Sea, the Belts and the Sound (amend. Regulation (EEC) No 1866/86)

OBJECTIVE: to apply, as from 1996, certain technical measures adopted by the International Baltic Sea Fisheries Commission (IBSFC), the organization that lays down the rules concerning the conservation and management of fishery resources of the Baltic Sea. The Baltic Sea Commission recommends every year maximum catch levels as well as measures to ensure the conservation and responsible exploitation of fishery resources. **COMMUNITY MEASURE:** Council Regulation (EC No 1821/96 amending for the sixth time Regulation (EEC) No 1866/86 laying down certain technical measures for the conservation of fishery resources in the waters of the Baltic Sea, the Belts and the Sound. **SUBSTANCE:** the sixth amendment of Regulation (EEC No 1866/86 is designed to implement, from 1996, certain new technical measures adopted at the last annual meeting of the IBSFC. These measures concern the closed seasons for the cod fishery and the salmon and sea trout fishery. **DATE OF ENTRY INTO FORCE:** 21 September 1996. The Regulation is applicable from 1 January 1996. ?
