Imports into the Canary Islands of sensitive products: derogation of anti-dumping measures (amend. regul. 1602/92/EEC)

-OBJECTIVE : granting an additional period of one year (up to 31 December 1996) to operators in the Canary Islands importing sensitive products into the Canary Islands, before the progressive application of anti-dumping duties from 1 January 1997. -SUBSTANCE : from 1 January 1996 Regulation (EEC) No 1602/92 introduced specific measures for the collection of anti-dumping duties on sensitive products imported into the Canary Islands in annual stages of 20%, becoming payable in full on 1 January 2000. By letter of November 1995 the Spanish authorities requested that the first period of full exemption from payment of anti-dumping duties should be extended for one year (up to 31 December 1996) so that the first period of collection should not start until 1 January 1997 so as to allow operators in the Canary Islands to adjust to the new tariff arrangements being introduced. This regulation simply aims to adjust the specific arrangements for anti-dumping duties accordingly. ?

The rapporteur felt that the Commission's proposal was fully justified given that, despite the recent economic growth, the current level of development of the Canary Islands was still a long way behind the per capita GDP in Europe. By promoting customs policy and commercial policy measures, as in this case, the EU could help significantly to bring the peripheral regions closer to the average European development levels. Nevertheless, before giving its opinion on the current proposal for a regulation, the REX Committee would have preferred to have an assessment of how the economy of the Canary Islands was affected by customs measures and specific arrangements for the non-application of commercial policy (Regulations No 1602/92 and 1605/92),. ?

Imports into the Canary Islands of sensitive products: derogation of anti-dumping measures (amend. regul. 1602/92/EEC)

- OBJECTIVE: to grant a further year's grace (until 31 December 1996) to Canary Island firms importing sensitive products into the Canary Islands, before anti-dumping duties on imports were gradually enforced, starting on 1 January 1997. - COMMUNITY MEASURE: Council Regulation (EC) No 363/96 amending Regulation (EEC) No 1602/92 temporarily derogating from implementation of Community anti-dumping measures on imports into the Canary Islands of certain sensitive products. - SUBSTANCE: with effect from 1 January 1996, Regulation (EEC)

No 1602/92 laid down arrangements for gradual collection of anti-dumping duties, applicable when sensitive products were imported into the Canary Islands. The amount of duty was to increase by 20% a year, and the full duty would be payable from 1 January 2000. In a letter dated November 1995 the Spanish authorities requested a one-year extension (until 31 December 1996) of the period of total exemption from duty. The first collection period would accordingly not start until 1 January 1997, thus allowing Canary Island firms to adjust to the new arrangements about to be phased in. The Regulation makes the necessary alterations to the specific arrangements applying to anti-dumping duties within the transitional period expiring on 31 December 2000, and the full amount of duty will consequently begin to be collected on 1 January 2001. - ENTRY INTO FORCE: 04.03.1996 The Regulation applies with effect from 1 January 1996. ?

The Council amended Regulation (EEC) No 1602/92 temporarily derogating from implementation of Community anti-dumping measures on imports into the Canary Islands of certain sensitive products.
