Quality wines produced in specified regions (amend. regul. 823/87/EEC)

incorporating new specific traditional terms defined by Germany. SUBSTANCE: under the proposed Regulation: - new specific traditional terms may be used in Germany to designate quality wines produced in specified regions (qwpsr); and - the name of a new qwpsr may be used for a transitional period to designate table wines which have traditionally been called by that name. ?

Quality wines produced in specified regions (amend. regul. 823/87/EEC)

In adopting the report by Mrs Christina KLASS (PPE, D), Parliament approved the proposal for a regulation allowing all Member States to use the term 'Crémant' but proposed, as an additional requirement, the criterion that traditional wine varieties should be used. This would open up the possibility of marketing Crémant under regional labels. Parliament called for prohibition of the use of 'Champagne'-type bottles for imitation sparkling wines. It also called for the labelling to include the name or business name of the producer of quality sparkling wines psr, the name of the commune or part of commune and of the Member State where the producer has his registered place of business. The labelling may be supplemented with the name of the vendor established in the Community. ?

Quality wines produced in specified regions (amend. regul. 823/87/EEC)

OBJECTIVE: to adopt an amendment to Regulation (EEC) No 823/87 laying down special provisions relating to quality wines produced in specified regions. COMMUNITY MEASURE: Council Regulation (EC) No 1426/96 amending Regulation (EEC) No 823/87. SUBSTANCE: the amendment adopted by the Council was intended to: - introduce new specific traditional terms that may be used in Germany to designate quality wines produced in specified regions (qwpsr); - allow the name of a new qwpsr to be used for a transitional period to designate table wines which have traditionally been called by that name; - make an exception in the case of the 'Manzanilla' qwpsr to the principle whereby the specified region from which a wine is obtained must be designated by its geographical name and hence permit the use of the above-mentioned traditional term to designate the product in question; - stipulate that geographical designations normally applied to wines may not be used for beverages not falling within the wine sector unless all risk of confusion can be ruled out and the geographical designation in question has been appropriately recognized.
