EC/Turkey Customs Union: Community position in the Joint Committee

- OBJECTIVE: to lay down the procedure for adopting the Community's position in the EC-Turkey Customs Union Joint Committee. -
SUBSTANCE: The procedure is determined according to the purpose and content of the acts to be adopted by the Joint Committee. The Joint Committee is required to intervene when the free trade guaranteed by the Customs Union is or may be adversely affected by unilateral measures taken by either party. The basis for the powers in question is thus Article 113 of the EC Treaty. Community positions will therefore generally be adopted by a qualified majority on a proposal from the Commission. However, a streamlined procedure, involving the Commission alone, will be employed when the Community's position relates to enforcement of Community legislation, providing for technical adjustments where necessary, or assessment of a practice constituting an infringement of competition. ?

EC/Turkey Customs Union: Community position in the Joint Committee

The Committee on Foreign Affairs unanimously adopted the report by P. KITTELMANN (PPE, D) in support of the draft Council decision establishing a procedure for adopting the Community's position within the Customs Union Joint Committee with Turkey. The main amendment seeks to ensure that Parliament is informed of the decisions taken by the Joint Committee in the same way as under the regulation in application of the European Economic Area.?

EC/Turkey Customs Union: Community position in the Joint Committee

In adopting the report by Mr Peter KITTELMANN (PPE, D), Parliament approved the proposal for a decision with the following amendments: - it called for the position to be taken by the Community within the Customs Union Joint Committee actually to relate to the simple transposition into the Customs Union of acts of Community law, and for an annual report to keep the EP informed of the decisions taken by the Joint Committee, - it specified that the Council should act in accordance with the procedures laid down for the adoption of internal rules for the area in question (and not merely by a qualified majority). ?

EC/Turkey Customs Union: Community position in the Joint Committee

In adopting the report by Mr Peter KITTELMANN (PPE, D), the European Parliament approved the reconsultation of the Council on the proposal for a decision laying down the procedure for adopting the Community's position within the EC-Turkey Joint Committee. Parliament had already delivered a favourable opinion on this proposal on 18 July 1996, but the Council decided to change the legal basis of the proposal and therefore asked Parliament for its opinion again, this time on the basis of Article 113 of the EC Treaty. To the extent that this change in the legal basis does not affect Parliament's right to information or the functioning of the Joint Committee itself, it was felt that the Council's new proposal could be approved. ?

EC/Turkey Customs Union: Community position in the Joint Committee

OBJECTIVE: to lay down the procedure for adopting the Community's position in the EC-Turkey Customs Union Joint Committee.
COMMUNITY MEASURE: Council Decision 97/833/EC laying down the procedure for adopting the Community's position in the Customs Union Joint Committee set up by Decision No 1/95 of the EC-Turkey Association Council on implementation of the final phase of the Customs Union. SUBSTANCE: The procedure is laid down by reference to the object and substance of the acts to be adopted by the Joint Committee. The Committee is required to act when the free trade guaranteed by the Customs Union is, or may be, affected by unilateral measures by either party. Thus the powers concerned are based on Article 113 of the Treaty on European Union. Community proposals will therefore, as a rule, be adopted by a qualified majority on a proposal from the Commission. However, a less cumbersome procedure, involving only the Commission, is to be adhered to when the position concerns the application by Turkey of legislation to transpose Community acts, if necessary by means of technical adjustments, or concerns the assessment of anticompetitive behaviour. The decision states that the Commission's annual report on the implementation of the Customs Union is also to be forwarded to the European Parliament and to contain information on decisions taken by the Joint Committee.
