## Resolution on the report on the future objectives of education and training systems

---

In adopting the resolution, the European Parliament regrets that it was not involved in the general reflection and the drawing up of the report on the 'concrete future objectives of education and training systems' which was submitted to the European Council in Stockholm. MEPs consider this report to be a major political breakthrough, but warn that the 'open method of coordination' established by the Lisbon European Council must not lead to failure to respect the role assigned to the institutions in the Treaties. They therefore insist that Parliament be closely involved in drawing up the follow-up report and in the measures to be taken. ?

## Resolution on the report on the future objectives of education and training systems

---

Following the conclusions of the Stockholm European Council 23/24 March 2001, the debate in Council centred around concrete measures to advance the work initiated by the last Education Council Report of 12 February 2001, and on the next steps for the follow-up report for Barcelona European Council in March 2002. It agreed that work would start on the following three areas which were emphasised in Stockholm: - basic skills - information and communications technology - mathematics, science and technology Indicators, whilst important, need to be underpinned by clearly defined, comparable and policy-relevant data. The active involvement and contribution of Member States was also emphasised.?
