The rights of the disabled

At the petitions committee Mary Banotti MEP (Ireland, EPP) presented her draft report on the rights of disabled people. This report is the result of the many petitions that have been brought to the attention of the committee in the past few years and have included issues such as rights to information and rights to access. Mrs Banotti has undertaken an extensive consultation process by contacting MEPS and NGOs in the European Disability Forum. Her investigations have shown that despite making up 10% of the population disabled people do not enjoy the whole spectrum of civil rights that non-disabled people have access to. This report, unanimously agreed after amendments, represents the first step in the path to increased representation of people with disabilities. Mrs Banotti urged that all MEPs on the Committee consider with care the translated versions in their respective languages. The report calls for a non-discrimination clause on the grounds of the disability in the revised Treaty on European Union and to ensure that existing national legislation is fully complied with. ?

The rights of the disabled

In adopting the report by Mrs Mary BANOTTI (PPE, IRL) on the rights of disabled people, the European Parliament called on Member States to include a non-discrimination clause on the grounds of disability in the revised Treaty on European Union, to adopt a new legal basis for social programmes, to introduce non-discriminatory measures and to treat the rights of disabled persons as a civil law issue. It urged the Commission to present a new action programme on equal opportunities for the disabled and to conduct censuses in all Member States in order to improve the statistics on the causes and severity of the various forms of handicap. Parliament called on the Community institutions and Member States to revise their policy on access and employment and also urged them to introduce measures to ensure that the freedom of movement of blind and partially-sighted persons was not restricted by prohibitions on access to guide dogs. ?
