Support system for producers of certain arable crops (amend. Regul. 1765/92/EEC, repeal. Regul. 1541/93/EEC)

The Council held a public debate - in accordance with the conclusions of the Edinburgh European Council on transparency - on the Commission proposals on the prices for agricultural products and on related measures for the 1996/1997 marketing year. The debate was introduced by Commissioner FISCHLER, who stressed that the proposals fell within the framework of price stabilization and of further simplification of the 1992 reforms, at a time that was generally favourable to farmers in economic terms. The Ministers gave their preliminary reactions to the proposals which, although prompted by recent CAP developments, did not entirely meet the problems arising for farmers and therefore needed to be supplemented. They also recognized the need to conclude negotiations on the matter in the near future in order to satisfy the expectations of the agricultural world in due course. At the end of its discussions the Council instructed the Special Committee on Agriculture to examine the dossier and submit a comprehensive report to it for a forthcoming meeting, with a view to an early conclusion once the European Parliament had delivered its Opinion.?

Agricultural prices and related measures 1996/97 - Arable crops. When fixing the rate of set-aside for the1996/97 marketing year, the Council asked the Commission to Consider the possibility of proposing an amendment to Regulation (EEC) No 1765/92 so that, in future, as a general rule, an appropriate uniform rate of set-aside could be fixed. In order to obtain the same effect with a uniform rate as with the differentiated rates, the Commission proposes to fix the uniform basic rate of set-aside at 18%. As regards the rate of set-aside to apply for the 1997/98

marketing year, i.e. to the autumn and spring 1997 sowings, the Commission will, if necessary, make a specific proposal in July 1996, taking account of the forecasts for the 1996 Community harvest and market developments. In order to ensure consistency, given that the rate of compulsory set-aside will be the same for all Member States, the additional rate in the event of transfers of set-aside between farmers should be fixed at 3%. ?

In adopting the report by Mr Giacomo SANTINI (UPE, I), the European Parliament called for the set-aside requirement to be 10% and not 18% as proposed by the Commission, since it was essential to avoid the imposition of a single rate which was excessively high in relation to the situation on the world and Community markets. The EP also tabled amendments setting specific dates for compensatory payments. Furthermore, producers applying for a compensatory payment for oilseed should be entitled to an advance payment of no more then 70% of the projected regional reference amount. ?

The Council adopted Council Regulation (EC) 1575/96 amending Regulation (EC) No 1765/92 establishing a support system for producers of certain arable crops, and repealing Regulation (EC) No 1541/93. SUBSTANCE: - setting of a single rate of set-aside at 17.5%. - standardization of the additional rate at 3% in the event of transfer of set-aside between farmers. ENTRY INTO FORCE: 19 August 1996. The Regulation is applicable from the 1997/98 marketing year. ?
