Agricultural prices 1996/1997: monthly price increases for cereals

Agricultural prices and related measures 1996/97 - Cereals. The reductions in the monthly increase proposed by the Commission in the price packages since the beginning of the reform have not been accepted in full by the Council. Furthermore, interest rates are falling and this is likely to continue in the medium term. The Commission therefore proposes to fix the monthly increases at ECU 1.10 per tonne per month (instead of ECU 1.30 per tonne per month). ?

Agricultural prices 1996/1997: monthly price increases for cereals

In adopting the report by Mr Giacomo SANTINI (UPE, I), the European Parliament asked that, for the next marketing year, the monthly increases should be maintained at the same level as the previous year (the Commission wished to reduce these increases) in order to distribute the disposal of stocks more evenly over the marketing year, and for rises in the monthly increases that were applicable to the intervention price. It also called on the Commission to submit a proposal to extend to the 1996/97 marketing year the current provisions on the maximum moisture content for cereals with regard to eligibility for intervention. ?

Agricultural prices and related measure 1996/97 - cereals (monthly increases). COMMUNITY MEASURE: Council Regulation (EC) 1576/96. SUBSTANCE: reduction in the level of monthly price increases for cereals from ECU 1.30/tonne to ECU 1.10/tonne. ENTRY INTO FORCE: 19 August 1996. ?
