Agricultural prices 1996/1997: derived intervention prices for white and raw sugar, minimum price for A and B beet

Agricultural prices and related measures 1996/97 - Sugar. The Commission proposes to maintain unchanged the basic price for beet, the intervention price for white sugar and the manufacturing margin. Therefore the 1996/97 price proposals for sugar are as follows: - Basic price for beet: ECU 47.67/tonne - Minimum price for B beet: ECU 32.42/tonne - Intervention price for white sugar: ECU 63.19/100 kg - Target price for white sugar: ECU 66.50/100 kg - Intervention price for raw sugar: ECU 52.37/100 kg With regard to reimbursement of storage costs, the Commission proposes that the amount of the monthly refund be reduced from ECU 0.45/100 kg to ECU 0.41/100 kg of white sugar per month (-8.9%) to take account of lower interest rates in the Community. ?

Agricultural prices 1996/1997: derived intervention prices for white and raw sugar, minimum price for A and B beet

Adopting the report by Mr Giacomo SANTINI (UPE, I), the European Parliament called for an increase in the amount of the reimbursement for storage costs from ECU 0.41/100 kg (Commission proposal) to ECU 0.45/100 kg, the present amount, in view of uncertainty about interest rates and the disparities between different countries. Furthermore, in order to deal with natural disasters (e.g. drought), the EP called for the period of compulsory storage to be reduced by one year for a quantity allowing normal supplies to the affected region.?

Agricultural prices 1996/1997: derived intervention prices for white and raw sugar, minimum price for A and B beet

Prices for agricultural products and related measures (1996-97) - Sugar (derived intervention prices for white sugar, intervention price for raw sugar, minimum prices for A and B beet, storage costs). COMMUNITY MEASURE: Council Regulation (EC) No 1580/96. SUBSTANCE: no changes to the basic price of beet, the intervention price for raw sugar or the producer margin. The prices for 1996-97 are therefore as follows: - Derived intervention prices for white sugar: ECU 64.65/100 kg for areas in the United Kingdom, Ireland, Portugal and Finland; ECU 64.88 for all areas in Spain; ECU 65.53 for all areas in Italy; - Intervention price for raw sugar: ECU 52.37/100 kg, - Minimum price for A beet: ECU/t 46.72, - Minimum price for B beet: ECU/t 32.42, In relation to compensation for storage costs, the amount of the monthly reimbursement is reduced from ECU 0.45 to ECU 0.42 per 100 kg of white sugar per month to take account of the fall in interest rates in the Community. In relation to sugar storage costs, the calculation will be based on an interest rate of 6.10% in place of 6%. ENTRY INTO FORCE: 19 August 1996. ?
