Agricultural prices 1996/1997: aid for the consumption of olive oil (amend. regul. 3089/78/EEC)

Agricultural prices and related measures 1996/97 - Olive oil. The Commission proposes certain minor adaptations to the consumption aid regime resulting from implementation of the Uruguay Round agreements. They include in particular suppression of the requirement that olive oil benefiting from the aid should be produced in the Community, and of the obligation for importers of olive oil (with the exception of olive oil imported from Tunisia under the quota benefiting from special arrangements) to constitute a guarantee equal to the amount of the consumption aid payable on the quantity imported. These adaptations are a consequence of the inclusion in the common customs tariff of an amount equal to that of the guarantee to be constituted. They should come into force not later than 1 July 1996 when the transitional measures adopted under Council Regulation (EC) No 3290/94 will expire.?

Agricultural prices 1996/1997: aid for the consumption of olive oil (amend. regul. 3089/78/EEC)

Adopting the report by Mr Giacomo SANTINI (UPE, I), the European Parliament rejected the Commission's proposals to grant aid for consumption for imported products, i.e. those of non-Community origin. The EP thought that the Community preference should be guaranteed for genuine oil produced in Europe, pending the reform of the sector.?

Agricultural prices 1996/1997: aid for the consumption of olive oil (amend. regul. 3089/78/EEC)

Agricultural prices and related measures (1996-97) - Olive oil. COMMUNITY MEASURE: Council Regulation (EC) No 1582/96 amending Regulation (EEC) No 3089/78 laying down general rules in respect of aid for the consumption of olive oil. SUBSTANCE: the Regulation provides for minor alterations in consumption aid resulting from the implementation of the Uruguay Round agreements. Olive oil need no longer be of Community origin in order to be eligible for consumption aid, and importers of olive oil (excepting olive oil originating in Tunisia and imported within a quota under special arrangements) no longer have to lodge a security equal to the part of the consumption aid payable for the imported quantity. These adjustments are a consequence of the inclusion in the Common Customs Tariff of an amount equal to the security to be provided. ENTRY INTO FORCE: 19 August 1996. The Regulation is applicable from 1 July 1996. ?
