## Agricultural prices 1996/1997: system of aid for cotton

Agricultural prices and related measures 1996/97 - Cotton. The cotton regime was reformed last year and so no major changes are proposed: the prices, the NGQ for each Member State and thus the MGQ were all fixed for a five-year period. The Commission nevertheless proposes to amend the basic Council Regulation (95/1554/EC) in order to provide for a variable amount of advance. This advance will be based on the difference between a provisional estimate of the target price and the observed daily world price. The provisional estimate of the target price will correspond to the target price reduced by a provisional abatement. This will result from any application of the MGQ stabilizers which production forecasts indicate will be necessary. For these purposes these production forecasts will be inflated by 15% in order to provide a safety margin to ensure that aid advance payments do not exceed final aid payments. The final payment, to be made as soon as final production figures are available, will thus become a flat-rate sum equal to the difference between the provisional abatement and its definitive level. Moreover, to simplify management of the regime, the Commission proposes to provide that the demand for aid must be lodged on the same day as the cotton is placed in supervised storage. ?

Adopting the report by Mr Giacomo SANTINI (UPE, I), Parliament thought that the present rules for lodging applications should be left unchanged, since reforms to the cotton sector had been introduced recently. Also, according to the EP, estimates of ginned cotton production should be increased by 8% (instead of 15%) as a safety margin to ensure that advances on aid do not exceed the final amount of the aid paid.?

Agricultural prices and related measures (1996-97) - Cotton COMMUNITY MEASURE: Council Regulation (EC) No 1584/96 amending Regulation (EC) No 1554/95 laying down the general rules for the system of aid for cotton. SUBSTANCE: - withdrawal of the possibility of aid being fixed in advance; - granting of an advance on aid whose variable level is based, on the one hand, on the guide price fixed at ECU 106.30/100 kg of ginned cotton and its abatement resulting, on the one hand, from the difference between the estimated production of each Member State, increased by 15%, and its threshold level and, on the other hand, from the world market price for ginned cotton. The result of this is a fixed balance for all the producers of the Member State concerned. ENTRY INTO FORCE: 19 August 1996. ?
