Agricultural prices 1996/1997: amounts withheld to promote the use of flax fiber and hemp

Agricultural prices and related measures 1996/97 - Fibre flax and hemp. - Fibre flax: for the 1996/97 marketing year, the Commission proposes to maintain the current aid level and the current amount retained to finance promotion actions at ECU 935.65 (before any aid abatement) and ECU 53.64 per hectare respectively. - Hemp: in view of the current unforeseeable market situation for hemp and the level of aid proposed for fibre flax, the Commission considers that the areas sown with hemp can be kept at the current level by keeping the aid for 1996/97 at ECU 774.74 per hectare. ?

Agricultural prices and related measures 1996/97 - flax and hemp. COMMUNITY MEASURE: Council Regulation (EC) 1585/96 fixing the amounts of aid for fibre flax and hemp and the amount withheld to finance measures to promote the use of flax fibre. SUBSTANCE: - Flax: for the 1996/97 marketing year, the level of aid is fixed at ECU 865.48/ha (reduction of 7.5%) and the amount levied with a view to financing promotion measures at ECU 49.62/ha. - Hemp: maintenance of aid at ECU 774.74/ha, which will mean the status quo in the areas sown to flax during the marketing year. ENTRY INTO FORCE: 19 August 1996. The Regulation is applicable from 1 August 1996. ?
