Agricultural prices 1996/97 - Milk and milk products The current situation on the market for milk products seems fairly balanced and does not therefore require corrective action this year on prices or quota levels. The Commission therefore proposes to maintain the target price for milk and the intervention prices for milk products at the same level as the previous marketing year for the period 1 July 1996 to 30 June 1997, i.e.: - target price for milk: ECU 30.98 per 100 kg. - intervention price: butter: ECU 328.20 per 100 kg. skimmed milk powder: ECU 205.52 per 100 kg. ?

The Council adopted Regulation 96/1188/EC fixing the target price for milk and the intervention prices for butter and skimmed-milk powder for the period from 1 July to 30 June 1997. The Council adopted the Regulation on 26 June 1996, in anticipation of a general agreement on a prices package and in order to avoid the risk of a legal vacuum affecting products whose season commenced on 1 July 1996.
