Agricultural prices 1996/1997: intervention price for adult bovine animals

Agricultural prices 1996/97 - Beef and veal. With regard to the intervention price for large bovines for the 1996/97 marketing year, the Commission proposes to maintain the level of ECU 347.5/100 kg deadweight for male carcasses of quality R3. No other prices are required to be fixed since the obligation to fix yearly a guide price was removed by the Council (Uruguay Round agreement). ?

The Council adopted the Regulation on 26 June 1996, in anticipation of a general agreement on a prices package and in order to avoid the risk of a legal vacuum affecting those products whose season commenced on 1 July 1996.

Agricultural prices 1996/1997: intervention price for adult bovine animals

1996/97 agricultural prices - beef and veal. The Council adopted Regulation 96/1189/EC fixing, for the 1996/97 marketing year, the intervention price for adult bovine animals. The regulation provides for the maintenance of the intervention price at its current level (ECU 347,5 100 kg carcass weight for males of R3 quality) and fixing, with effect from 1 July 1996, the starting date for the marketing year at 1 July of each year. ?
