Agricultural prices 1996/97 - Sheepmeat and goatmeat The institutional prices for the 1996 marketing year were fixed in the 1995/96 price package. For 1997, the Commission proposes that the basic price remain at the level already decided for 1996, i.e. ECU 504.07 per 100 kg. (carcase weight). The Commission also proposes that the seasonalization of the basic price remain unchanged. ?
