Agricultural prices and related measures 1996/97 - Sparkling wines and liqueur wines. Pending the establishment of the new common market organization in wine, the Commission proposes to extend until 1 April 1997 the deadline for the submission by the Commission of reports to the Council on the maximum content of sulphur dioxide of sparkling wines and liqueur wines, possibly containing appropriate proposals. The Council would thus decide on possible measures to be applied as of 1 September 1997. ?

Agricultural prices 1996/97 - Sparkling wines and liqueur wines. COMMUNITY MEASURE: Council Regulation (EC) 1594/96 amending Regulations (EEC) Nos 2332/92 and 4252/88. SUBSTANCE: Pending adoption of the reform of the common market organization in the wine sector, postponement until 1 April 1997 of the deadline for the presentation by the Commission of the reports to the Council on the maximum sulphur dioxide content of sparkling wines and of liqueur wines, possibly accompanied by the appropriate proposals. The Council will decide on any measures applicable from 1 September 1997. ENTRY INTO FORCE: 19 August 1996. ?
