Agricultural prices and related measures 1996/97 - Wine (permanent abandonment premium in respect of wine-growing areas) The rules currently in force concerning the ban on new planting and the system granting Community premiums for grubbing up vines are due to expire in the course of the current marketing year. Pending a decision on the set-up measures proposed under the reform, the Commission proposes to extend the system in force for an additional year. ?

COMMUNITY MEASURE: Council Regulation (1595/96) amending Regulation (EEC) 1442/88. SUBSTANCE: The grubbing-up arrangements are extended for two years (until the 1997/1998 wine year) but are only applicable to those regions designated by the Member State concerned (it being understood that a Member State may choose not to designate any region). The number of hectares for which grubbing-up may be authorized in each of the years concerned may not exceed the following figures: - Germany: 50 ha - Greece: 985 ha - Spain: 13 000 ha - France: 3 895 ha - Italy: 5 785 ha - Luxembourg: 15 ha - Austria: 15 ha - Portugal: 1 255 ha - Total: 25 000 ha. ENTRY INTO FORCE: 19 August 1996. ?
