Given the state of the work for the establishment of vineyard registers in the Member States concerned and in the light of experience, the Commission proposes to extend the deadline for the completion of the simplified vineyard register (basic reference chart) to 31 December 1988 instead of 31 December 1996 as was decided at the time of the adoption of the price package last year. ?
