EC/Guinea fisheries agreement: protocol for the period from 1st January 1996 to 31st December 1997

- OBJECTIVE: Conclusion of a new protocol on fisheries between the Community and the Republic of Guinea laying down the technical and financial conditions for the exercise of fishing activities by Community vessels in Guinean waters for the period from 1 January 1996 to 31 December 1997. - SUBSTANCE: The protocol initialled by both parties on 6 December 1995 provides for the following fishing opportunities: Licences for trawlers (fin fish, cephalopods and shrimp): 5 000 GRT per month, annual average; . licences for 28 freezer tuna seiners; . licences for 7 pole and line tuna vessels; . licences for 7 surface long liners. In return, the Republic of Guinea will receive financial compensation totalling ECU 2 400 000 payable in two annual instalments (ECU 1 150 000 and ECU 1 300 000 respectively), on the understanding that the fishing opportunities for shrimp, fin fish and cephalopod trawlers may be increased at the request of the Community by successive instalments of 1 000 GRT every month, calculated on an annual average basis. In this case, the financial compensation would be increased proportionately. In addition to this financial compensation, the Community will contribute: . ECU 400 000 towards the financing of scientific or technical programmes to develop the fisheries sector; . ECU 250 000 in bursaries to Guinean fishermen to study or undergo practical training in the Community. The Community shall also contribute a total of ECU 900 000 towards the financing of three local programmes (fisheries surveillance, institutional aid for the Ministry for Fisheries, aid for non-industrial fishing). ?

EC/Guinea fisheries agreement: protocol for the period from 1st January 1996 to 31st December 1997

The Committee on Fisheries unanimously adopted the draft legislative resolution embodying the opinion of the European Parliament on the new financial instrument in the fisheries agreement with Guinea. The rapporteur, Mr MACARTNEY (ARE, UK), found the delay in consulting Parliament (once the agreement had been concluded and implemented) unacceptable, but confirmed his support for the proposal in question. He also called for an adequate monitoring procedure in the form of a Commission report assessing the implementation of the current protocol by the end of 1997 and well before its renewal was negotiated. This report should, inter alia, evaluate the use made of fishing rights obtained by Community vessels and how funds for specific support programmes granted to the third country concerned have been used.?

EC/Guinea fisheries agreement: protocol for the period from 1st January 1996 to 31st December 1997

In adopting the report by Mr MACARTNEY (ARE, UK) Parliament approved this proposal for a regulation, calling on the Commission to submit a report to it by 31 December 1997 on how Union funds specifically allocated for support programmes for fisheries surveillance bodies (ECU 350 000), institutional support for the Fisheries Ministry (ECU 300 000) and aid for small-scale fishing (ECU 250 000) have been used.?

EC/Guinea fisheries agreement: protocol for the period from 1st January 1996 to 31st December 1997

OBJECTIVE: conclusion of a new protocol on fisheries between the Community and the Republic of Guinea for the period from 1 January 1996 to 31 December 1997. COMMUNITY MEASURE: Council regulation 909/97/EC on the conclusion of the protocol establishing, for the period 1 January 1996 to 31 December 1997, the fishing rights and financial compensation provided for in the agreement between the European Community and the government of the Republic of Guinea on fishing off the Guinean coast. SUBSTANCE: The protocol provides for the following fishing opportunities: Licences for trawlers (fin fish, cephalopods and shrimp): 5 000 GRT per month, annual average; . licences for 28 freezer tuna seiners; . licences for 7 pole and line tuna vessels; . licences for 7 surface long liners. In return, the Republic of Guinea will receive financial compensation totalling ECU 2 400 000 payable in two annual instalments (ECU 1 150 000 and ECU 1 300 000 respectively), on the understanding that the fishing opportunities for shrimp, fin fish and cephalopod trawlers may be increased at the request of the Community by successive instalments of 1 000 GRT a month, calculated on an annual average basis. In this case, the financial compensation would be increased proportionately. In addition to this financial compensation, the Community will contribute: . ECU 400 000 towards the financing of scientific or technical programmes to develop the fisheries sector; . ECU 250 000 in bursaries to Guinean fishermen to study or undergo practical training in the Community. The Community shall also contribute a total of ECU 900 000 towards the financing of three local programmes (fisheries surveillance, institutional aid for the Ministry for Fisheries, aid for non-industrial fishing). ENTRY INTO FORCE: the regulations shall enter into force on 26 May 1997. The protocol shall enter into force once both parties have given the necessary notifications.
