## EC/Ukraine Partnership and Cooperation Agreement. Protocol following the 1995 enlargement

OBJECTIVE: adoption of a protocol to the Partnership and Cooperation Agreement between the European Community and Ukraine in order to take into account the accession of Austria, Finland and Sweden to the Community. SUBSTANCE: this protocol seeks only to insert the names of the three new Member States which acceded to the Community on 1 January 1995 (Austria, Finland, Sweden) in the list of signatory states to the EC-Ukraine Partnership Agreement. ?

The committee recommended that the European Parliament assent to the Council and Commission proposal on the conclusion of partnership and cooperation agreements with the Ukraine. Mr Alfred GOMOLKA (PPE, D) noted that the situation in this country was alarming: "the economy is on its knees and the situation is desperate". It should be noted that, although the European Parliament assented to this agreement in November 1995, a number of Member States (Belgium, Italy and Portugal) have yet to ratify it.?

## EC/Ukraine Partnership and Cooperation Agreement. Protocol following the 1995 enlargement

PURPOSE: to adopt a protocol to the Partnership and Cooperation Agreement between the

European Community and Ukraine in order to take into account the accession of Austria, Finland and Sweden to the Community.

LEGISLATIVE ACT: Council and Commission Decision 2000/638/EC, ECSC, Euratom on the conclusion of the Protocol to the Partnership and Cooperation Agreement establishing a partnership between the European Communities and their Member States, of the one part, and Ukraine, of the other part.

CONTENT: this Decision approves a protocol with a view to inserting the names of the three new Member States which acceded to the Community on 1 January 1995 (Austria, Finland, and Sweden) in the list of signatory states to the EC-Ukraine Partnership Agreement.

ENTRY INTO FORCE: the protocol shall enter into force when all the necessary procedures have been completed.
