## Transport of certain fresh fruit and vegetables from Greece (amend. Regul. 3438/92)

OBJECTIVE: amending Regulation 92/3438/EEC laying down special measures for the transport of certain fresh fruit and vegetables originating in Greece as regards their period of application. SUBSTANCE: Council Regulation (EEC) No 3438/92 provided for the grant in 1992, 1993 and 1994 of a special temporary allowance for the transport of certain Greek fresh fruit and vegetables to Community Member States other than Italy, Spain and Portugal as a result of the need for these products to avoid the territory of the former Yugoslavia. In view of the fact that transport conditions in some territories of the former Yugoslavia have not yet returned to what they were before the war, it is proposed that the Council prolong the measure for the first six months of 1996 (until 30 June 1996). ?

## Transport of certain fresh fruit and vegetables from Greece (amend. Regul. 3438/92)

The rapporteur proposed that the special temporary allowance granted to Greece be extended until the end of 1996 (the Commission had proposed 30 June 1996). This proposal was justified by the fact that the normal conditions of transport which applied prior to the war in former Yugoslavia had not yet been restored. The committee adopted the report by Mrs LAMBRAKI and proposed an emergency vote without debate during the June II 1996 sitting of the European Parliament. ?

## Transport of certain fresh fruit and vegetables from Greece (amend. Regul. 3438/92)

In adopting the report by Mrs Irini LAMBRAKI (PSE, Gr), Parliament proposed that the special temporary allowance granted to Greece should be extended until the end of 1996 (the Commission proposal was until 30 June 1996). ?

## Transport of certain fresh fruit and vegetables from Greece (amend. Regul. 3438/92)

OBJECTIVE: amending Regulation (EEC) No 3438/92 laying down special measures for the transport of certain fresh fruit and vegetables originating in Greece, in order to offset the additional costs arising from the need to bypass former Yugoslavia. COMMUNITY MEASURE: Regulation (EC) 1600/96. SUBSTANCE: The amendment adopted by the Council seeks to extend until 30 December 1996 the special allowance for transport to Greece, given the persistence of the severe conditions in certain territories of former Yugoslavia. The transport concerned is by goods train, lorry and ship, destined for other Member States with the exception of Italy, Spain and Portugal. ENTRY INTO FORCE: 19 August 1996. The regulation is applicable from 1 January 1996. ?
