Directive 1996/72 OJ L 304 27.11.1996, p. 0010 Summary

Marketing of beet seed, fodder-plant seed, cereal seed, seed potatoes, seed of oil and fibre plants

OBJECTIVE: amending, in order to bring them into line with the TEU, Directives 66/400/EEC, 66/402/EEC, 66/403/EEC, 69/208/EEC, 70/457/EEC and 70/458/EEC concerning the marketing of beetseed, fodder plant seed, cereal seed, seed potatoes, seed of oil and fibre plants and vegetable seed, and concerning the common catalogue of varieties of agricultural plants. SUBSTANCE: the abovementioned directives are in the process of being officially consolidated. They are also the subject of a Commission proposal which makes numerous amendments to the Directives in order to update them and bring them into line with the single market concept. It is therefore proposed to replace the abbreviation 'EEC' with the abbreviation 'EC' in the provisions of the said directives on packaging and labelling. Existing stocks of labels bearing the abbreviation 'EEC' may continue to be used until 31 December 1996. ?

The ESC approves the Commission proposal subject to the following objections: It considers that the 1 July 1996 deadline for the transposition into national legislation has been overtaken by events and is therefore impracticable. The Committee recommends that the same timeframe be laid down in all the Directives, and would refer in this connection to the common position of the Council on the labelling of dangerous substances.. ?

COMMUNITY MEASURE: Council Directive 96/72/EC. SUBSTANCE: The Directive provides for replacing the abbreviation 'EEC' with the abbreviation 'EC' in the provisions of the said directives on packaging and labelling. Existing stocks of labels bearing the abbreviation 'EEC' may continue to be used until 31 December 2001. DATE OF ENTRY INTO FORCE: 17 December 1996. DEADLINE FOR TRANSPOSITION: 1 July 1997. ?
