EC/Uzbekistan Partnership and Cooperation Agreement

The Council agreed to the Commission's recommendation for the opening of negotiations with Uzbekistan for a partnership and cooperation

agreement on the basis of the negotiating directives drawn up in 1992. The Commission's recommendation follows its exploratory talks with Uzbekistan on the basis of the Council conclusions of 12 June 1995 with particular regard to the progress of democratic reforms?

EC/Uzbekistan Partnership and Cooperation Agreement

OBJECTIVE: conclusion of a partnership and cooperation agreement between the Community and its Member States and the Republic of Uzbekistan. **SUBSTANCE:** this is a mixed agreement covering areas for which both the Community and the Member States are competent. It is concluded for an initial period of ten years and comprises the following elements: . establishment of a political dialogue; . provisions covering trade in goods, labour conditions, establishment and operation of companies, cross-border supply of services, payments and capital, competition, intellectual, industrial and commercial property protection, legislative cooperation, economic cooperation, respect for democracy and human rights, cooperation in combating illegal activities and illegal immigration, cultural cooperation and financial cooperation; . human rights conditionality clause, allowing the agreement to be suspended, even unilaterally, in the event of violation of the agreement's essential elements such as respect for democratic principles, human rights and the principles of the market economy. . The agreement creates an institutional framework comprising a Cooperation Council, a Cooperation Committee and a Parliamentary Cooperation Committee. . The provisions concerning customs cooperation are covered by a separate protocol. . Finally, where trade relations between the Republic of Uzbekistan and the Community are concerned, the agreement will replace the 1989 agreement on trade and commercial and economic cooperation between the Community and the USSR. ?

EC/Uzbekistan Partnership and Cooperation Agreement

The Committee adopted without amendment the report by Anne Andre-Leonard (ELDR, B) which gives assent to the proposed Partnership and Cooperation Agreement between the EU and Uzbekistan.. The Agreement was signed in June 1996 but the Committee had delayed its ratification as it wished to monitor the human rights situation in Uzbekistan. However an interim agreement covering trade matters did enter into force. In view of the attempts by the Uzbek government to improve the human rights situation and to promote democracy, Mrs Andre-Leonard can now give her approval to the agreement, however she wants the situation to be closely monitored. The accord is almost identical to other partnership agreements with countries of the former Soviet Union and lays down the framework for extensive cooperation between the EU and Uzbekistan in many fields (excluding military matters).?

EC/Uzbekistan Partnership and Cooperation Agreement

The Parliament adopted its recommendation, drafted by Ms. Anne ANDRE-LEONARD (ELDR, Belgium), concerning the conclusion of the Partnership and Co-operation Agreement with Uzbekistan. It gave its assent to the proposal for a Council and Commission decision.?

EC/Uzbekistan Partnership and Cooperation Agreement

PURPOSE : to conclude the Partnership and Cooperation Agreement between the European Communities and their Member States and Uzbekistan. **COMMUNITY MEASURE :** Decision 1999/593/EC, ECSC, Euratom of the Council and the Commission relating to the conclusion of of the Partnership and Cooperation Agreement between the European Communities and their Member States, of the one part, and the Republic of Uzbekistan, of the other part. **CONTENT :** the decision aims to allow the conclusion of the Partnership and Cooperation Agreement between the Communities and the Republic of Uzbekistan. It relates to a mixed agreement covering the sectors of national and Community competences. The Agreement is concluded for a period of 10 years. The Agreement establishes a political dialogue of the highest level. It includes measures relating to trade of goods, employment conditions, the setting up and the activities of companies, the benefits of cross-border services, payments and capital, competition, protection of intellectual, industrial and commercial property, legal cooperation, economic, financial and cultural cooperation. In addition, the Agreement includes respect for the democracy and human rights, cooperation in the field of prevention of illegal activities and the control of clandestine immigration. There is a conditional 'human rights' clause allowing the suspension of the Agreement, even unilaterally, in the case of violation of essential elements of the Agreement, such as the respect for democratic principles and human rights and the principles of the market economy. The Agreement will be managed by a triple structure : a Cooperation Council, a Cooperation Committee and a Parliamentary Cooperation Commission. The measures relating to customs cooperation are the subject of a separate protocol. This Agreement replaces the 1989 Agreement on trade and commercial and economic cooperation between the European Communities and the Union of Soviet Socialist Republics. **ENTRY INTO FORCE :** 01.07.1999.?
