Aid to shipbuilding

OBJECTIVE: to amend Regulation EC No 3094/95 on aid to shipbuilding against the possibility of a delay in the entry into force of the OECD Agreement respecting normal competitive conditions in the commercial shipbuilding and repair industry and concluded between the EC and certain third countries. SUBSTANCE: given the uncertainties over the entry into force of the OECD Agreement, it is proposed that Directive 90/684/EEC should be prolonged until 31 December 1998, unless the OECD Agreement enters into force in the meantime. ?

Aid to shipbuilding

?The Council: - took note of the current situation as regards the ratification of the international agreement on the commercial shipbuilding and repair industry; - engaged in an exchange of views on the note submitted by the Danish delegation and on the working document from the Commission concerning transparency in the examination of cases of State aid to shipbuilding, which presented that institution?s views on the proposals contained in the note that the Danish delegation had presented to the Industry Council on 28 March 1996. the Council took note of the Commission?s intention to take additional measures to ensure that there were effective and transparent checks on state aid to shipbuilding in the European Union. The aim was to conclude these deliberations at the next Council meeting; - called on all parties to take immediate steps to ratify the OECD agreement on normal competitive conditions in the commercial shipbuilding and repair industry, without which it would not be possible to define a general policy for the shipbuilding industry that was based on market conditions and designed to guarantee fair competition; - called on the Commission to keep a close watch on developments in the ratification of the OECD agreement and to present

its new assessment of the situation at the earliest possible date, accompanied if necessary by suitable proposals, in accordance with the conclusions adopted by the Council of Industry Ministers on 6 and 7 November 1995.?

Aid to shipbuilding

Adopting the report by Mr Luigi MORETTI, the Economic and Monetary Committee (simple consultation) insisted that shipbuilding aid arrangements should not be dismantled before the entry into force of the relevant OECD agreement. It considered that Europe should not disarm in the face of competition in this sector which, if the agreement is not ratified, will continue to benefit from state aid.?

Aid to shipbuilding

In adopting the report by Mr Luigi MORETTI (ELDR, I), Parliament insisted that existing shipbuilding aid arrangements should not be dismantled before the entry into force of the relevant OECD Agreement. If the Agreement has not entered into force on 31 December 1997, the Commission should present to the European Parliament a study of the consequences for the shipbuilding industry of the absence of an Agreement along with a series of policy options for the future of the European shipbuilding industry.?

Aid to shipbuilding

The Committee is concerned that the implementation of the OECD agreement has again been delayed and it considers the proposal to extend the seventh Directive on aid to shipbuilding a necessary and minimal interim response. The Committee also thinks that the Commission should consider alternative options for influencing the future development of the shipbuilding industry in the European Union in case the OECD agreement is not ratified.?

Aid to shipbuilding

The Council adopted the Regulation by qualified majority, with the German, Finnish and Dutch delegations voting against the proposal.

Aid to shipbuilding

OBJECTIVE: amendment of Regulation (EC) No 3094/95 on aid to shipbuilding pending the entry into force of the OECD Agreement on normal competitive conditions in the commercial shipbuilding and repair industry between the EC and certain third countries. SUBSTANCE: since there are some uncertainties over the entry into force of the OECD Agreement, the amendment provides for a further prolongation of the relevant rules of Council Directive 90/654/EEC (Seventh Council Directive on aid to shipbuilding) pending the entry into force of the OECD Agreement and until 31 December 1997 at the latest. ?
