EC/ASEAN: extension of the EC/ASEAN cooperation agreement to Vietnam

OBJECTIVE: the decision seeks to extend the cooperation agreement concluded between the Community and the ASEAN member states to the Republic of Vietnam. SUBSTANCE: Following Vietnam's accession to ASEAN on 28 July 1995, the Community intends to extend the cooperation agreement which has linked it to this organization since 7 March 1980 (then extended to Brunei on 21 March 1985) to Vietnam. The extension of the cooperation agreement takes the form of a protocol and does not include a financial protocol.?

EC/ASEAN: extension of the EC/ASEAN cooperation agreement to Vietnam

The Committee is recommending to Parliament, in line with the rapporteur Mr HINDLEY (PSE,UK), the endorsement of the extension to Vietnam of the Cooperation Agreement between the European Community and the countries of the Association of South-East Asian Nations (ASEAN: Indonesia, Malaysia, the Philippines, Singapore, Thailand, Brunei and, since 1995, Vietnam). The extended EC-ASEAN agreement will be applied to Vietnam in parallel with the bilateral Cooperation Framework Agreement concluded between the EC and Vietnam in 1995. The bilateral agreement is more modern and complete and, for that matter, takes precedence, in case of conflict, over the provisions of the EC-ASEAN agreement. In particular, the former contains a human rights clause which permits the suspension of the agreement in case of serious humans rights violations. The implementation of the human rights clause is, according to the rapporteur, extremely important not only in what concerns Vietnam, but also in the perspective of future treaties with other ASEAN member states which will have to include such a clause.

PURPOSE: extension of the Co-operation Agreement between the European Community and the members of ASEAN to the Socialist Republic of Vietnam. COMMUNITY MEASURE: Council Decision 1999/295/EC concerning the conclusion of the Protocol on the extension of the Co-operation Agreement between the European Community and the member countries of ASEAN to the Socialist Republic of Vietnam. CONTENT: This Council Decision relates to the conclusion of the Protocol on the extension of the Co-operation Agreement between the European Community and Brunei-Darussalam, Indonesia, Malaysia, the Philippines, Singapore and Thailand, member countries of the Association of South-East Asian Nations (ASEAN), to Vietnam. ENTRY INTO FORCE: As the ASEAN countries have already notified the Secretariat of the Council that they have accomplished the procedures necessary for the entry into force of this Protocol, signed on 14 February 1997, it will come into force on 1 May 1999 (first day of the month following the conclusion by all parties of their internal procedures).?
