OBJECTIVE: to grant the same supplementary amounts to tobacco producers in Austria as those granted in Germany, given the similarity of growing conditions in the two countries. SUBSTANCE: the Council is requested to adopt a proposal for a regulation amending Regulation (EEC) No 2075/92 on the common organization of the market in raw tobacco and granting supplementary amounts for flue-cured, light air-cured and dark air-cured tobaccos grown in Austria.
