Euro: legal framework for its use

OBJECTIVE: to propose, ahead of the start of stage III of EMU, the provisions that should make up the legal framework for the use of the euro and which will provide the necessary legal certainty for market participants and economic operators. SUBSTANCE: the proposal for a Council Regulation on some provisions relating to the introduction of the euro has the following objectives: - to confirm that, with effect from 1 January 1999, references to the ecu in contracts and other legal instruments are replaced by references to the euro at the rate of 1 Euro for 1 ECU; - to confirm the continuity of contracts which are denominated in national currencies and in ecu and which extend beyond 1 January 1999; - to determine the degree of precision at which conversion rates will be irrevocably fixed on 1 January 1999; - to establish rounding rules. Moreover, the proposal introduces the name 'euro' for the single currency into Community legislation. Reference to the decision of the European Council on the name is included in the recitals. ?

Euro: legal framework for its use

In adopting the report by Mr Fernand HERMAN (PPE, B), Parliament proposed a number of clarifications in order to reinforce legal certainty concerning transition to the euro. With regard to certainty over contracts, any clause permitting one of the parties to avoid his obligations in the event of the euro replacing one of the national currencies of the participating Member States will be deemed null and void if it is included in a standard contract or preprinted agreements which have not been individually negotiated between the parties. Parliament considered that it would be necessary to strengthen consumer protection against abuse and fraud in connection with the euro (amendment of Directive 93/13/EEC concerning unfair clauses in contracts; harmonization of national penal provisions in relation to prevention of fraud). It called on Member States to take appropriate action in conjunction with relevant trade, professional and consumer organizations to inform, advise and prepare for the introduction of the euro. Parliament rejected the amendments concerning double pricing. ?

Euro: legal framework for its use

OBJECTIVE: to fix, before the start of the third stage of Economic and Monetary Union, the provisions which will constitute the legal framework for the use of the euro in order to provide legal certainty for citizens and firms in all the Member States. COMMUNITY MEASURE: Council Regulation (EC) No 1103/97 on certain provisions relating to the introduction of the euro. SUBSTANCE: the regulation, in fixing certain provisions on the introduction of the euro, - confirms that with effect from 1 January 1999 the references to the ECU in contracts and other legal instruments will be replaced by a reference to the euro at the rate of one to one; - confirms the continuity of contracts expressed in national currencies and in ECU and which will reach their term after 1 January 1999 (the introduction of the euro will not have the effect of altering any term of a contract or of discharging or excusing its performance; it will not give a party the right unilaterally to alter or terminate a contract); - determines the degree of precision with which the conversion rates will be fixed irrevocably on 1 January 1999 (the conversion rates which are adopted are expressed in terms of the equivalent of a euro in each of the national currencies of the participating Member States; they have six significant figures). - sets the rules for rounding of amounts.
